Dear Judge Bailin:

The People, through District Attorney Mary T. Lacy, hereby request that this Court order the warrant and supporting affidavit, and all other associated documents submitted to this Court in connection with this arrest warrant, including this letter, be sealed for 90 days or until further order of this Court, except for use in any extradition proceedings to bring the suspect to this jurisdiciton. The People request that the Court order its staff and that of the Court Clerk to deny access to any and all of these documents for the pendency of the investigation or until the matter can be reviewed after charges are filed, pursuant to §24-72-305(5), C.R.S. and §24-72-204(2)(a)(I), C.R.S. The reasons for this request are stated below.

- 1. There is an ongoing murder investigation initiated by the Boulder Police Department and now pursued by the District Attorney for the Twentieth Judicial District into the homicide of JONBENET RAMSEY. The date of this homicide was between December 25, 1996 and December 26, 1996. No arrest has yet been made. The public and the press throughout this country and throughout the world have shown substantial interest in this investigation.
- 2. The District Attorney has submitted herewith an affidavit in support of an arrest warrant in this investigation. This was done as part of a lengthy and complicated cooperative effort of a number of law enforcement agencies in this country and abroad.
- 3. The suspect has not yet been taken into custody and is in a foreign country. It is highly likely he would flee and go into hiding if he were to learn that the authorities know his identity, whereabouts, and other information in these documents.
- 4. The affidavit, warrant, and other documents submitted to this Court in connection with the various search warrants issued to date contain specific information from the investigatory records of various law enforcement agencies, including the Boulder Police Department, the Boulder County District Attorney, and the Boulder County Coroner, about the homicide of JonBenet Ramsey. Some of that information has not been disclosed to anyone outside law enforcement.
- 5. The investigation to date has resulted in the identification of the suspect and his location, but substantial further investigation will be necessary.
- 6. Premature disclosure of these documents at this sensitive point in this new stage of this lengthy investigation would be likely to be detrimental to the effort to execute this warrant, apprehend the suspect, and to return the suspect to this jurisdiction. Likewise, premature disclosure of the information contained in these documents during the pendency of the investigation that will follow taking this suspect into custody could compromise those ongoing efforts, including impacting witness statements to law enforcement and otherwise jeopardize the ability of law

enforcement authorities to collect, interpret, and evaluate information and could impede further investigation and conviction of the killer.

- 7. Disclosure of the information within these records would be contrary to, and would do substantial injury to, the public interest involved in this ongoing investigation.
- 8. Pursuant to 24-72-305(5), C.R.S. (with regard to criminal justice records), the custodian of criminal justice records may allow inspection of such records except "on the ground that disclosure would be contrary to the public interest, and unless otherwise provided by law, the custodian may deny access to the records of investigations conducted by or of intelligence information or security procedures of any sheriff, district attorney, or police department or any criminal justice investigatory files compiled for any other law enforcement purpose."
- 9. The District Attorney, as custodian of the records of her office, has determined that disclosure of their records of this investigation, including disclosure of those portions of those records contained in the affidavit, warrant, and other documents submitted to this Court in connection with the various search warrants issued to date, would be contrary to the public interest and have determined to deny access to their records for the pendency of this investigation.
- 10. It is in the public interest that access to the records and files compiled by the law enforcement agencies involved in this investigation be denied during the pendency of the investigation, including those records and files which have been provided this Court in connection with the warrants which have been requested and approved.

Wherefore, the People respectfully request the Court seal the warrant, affidavit, and other documents submitted to this Court in connection with the arrest warrant issued today, including this request, except for use in any extradition proceedings to return the suspect to this jurisdiction, and that the Court order its staff and that of the Court Clerk to deny access to any and all of these documents for the pendency of the investigation or until the matter can be reviewed after charges are filed.

AFFIDAVIT FOR ARREST WARRANT

Your, affiant, Thomas A. Bennett, a duly sworn commissioned investigator for the Boulder County District Attorney's Office, County of Boulder, State of Colorado, deposes and says:

Your affiant, Chief Investigator Thomas A. Bennett of the Boulder County District Attorney's office has been so employed for a total of two (2) years. Prior to employment through the Boulder County District Attorney's Office, your affiant was employed through the City of Arvada Police Department for 28 years. During employment through the Arvada Police Department, your affiant was assigned to the Criminal Investigations Bureau (CIB) for 20 years. Your affiant was assigned to the Crimes Against Persons Unit of the CIB for 15 years and routinely investigated death investigations, including homicides, suicides, accidental deaths and natural deaths. Additionally, your affiant was assigned the investigation of Aggravated Robberies, Sexual Assaults and Felony Assaults. Your affiant has received specialized training regarding death investigation. which was sponsored through the Federal Bureau of Investigation (FBI) and other governmental agencies. Your affiant has received other specialized training pertaining to Crime Scene Investigation, Fingerprint Classification, Interview and Interrogation in addition to numerous other schools. Your affiant is a member of the Colorado Homicide Investigators Association and the Colorado Association of Robbery Investigators. Your affiant is a member of the Rocky Mountain Division of the International Association for Identification, which is an association composed of forensic specialists and other investigators who routinely provide assistance to law enforcement agencies in identifying perpetrators of crimes, as well as identifying deceased victims to which no visible means of identification are available. Your affiant is certified through the Colorado Peace Officers Standards and Training as an instructor in criminal investigations.

Your affiant requests an Arrest Warrant be issued based on the following:

On 12/26/96, at 5:57 AM, a 911 telephone call was received at the Boulder Police Department, address 1805 33rd Street, Boulder, Boulder County, Colorado. The caller identified herself as Patricia Ann Ramsey, DOB/ 12-29-56. Patricia, or "Patsy" as she is known by her family and friends, reported her daughter –JonBenet Ramsey DOB/08-06-90 (age 6 at the time of the incident) had been kidnapped from the Ramsey residence located at 755 15th Street, City of Boulder, Boulder County, Colorado. Ms. Ramsey added a handwritten ransom note had been left in the house. The kidnappers demanded \$118,000.00. The kidnappers indicated in the note that they would call back at 10:00 AM with further instructions.

Boulder Police Department Crime Report P96-21871 addresses the investigation.

Boulder Police Officer Rick French was the first officer to arrive at the scene and made contact with the parents of the victim, identified as John Bennett Ramsey DOB/12-07-43 and his wife Patricia Ramsey. The parents related that the previous evening, this being Christmas day 12/25/96, they along with JonBenet Ramsey age 6 and JonBenet's brother identified as Burke Hamilton Ramsey DOB/01-27-87 (age 9) had attended a Christmas party at a friends house and had returned to the Ramsey home at approximately 10:00 PM. JonBenet was asleep in the family vehicle upon arrival at the Ramsey residence. John Ramsey carried JonBenet from the family vehicle to the second floor bedroom she occupied in the home. JonBenet was last seen in her bed asleep at approximately 10:00 PM on 12/25/96. John Ramsey, his wife Patsy Ramsey and their son Burke also retired at approximately 10:30 PM. John and Patsy Ramsey retired to their upper level master bedroom. Burke retired to his own bedroom.

The Ramsey family had previously prepared for a trip to Charlevoix, Michigan the next morning (December 26, 1996) using a small private airplane.

Patsy Ramsey stated she awoke shortly after 5:30 AM the morning of 12/26/96 and was going to prepare for the trip to Charlevoix, Michigan. Patsy Ramsey checked the bedroom of JonBenet and noticed her daughter was not in her bed. Patsy descended a spiral staircase leading from the second floor to the first floor and found a 3-page handwritten note on the stairs. Ms. Ramsey briefly reviewed the note and determined that it was a note demanding ransom. Patsy Ramsey told her husband John Ramsey of the discovery of the note. Patsy and John Ramsey checked their daughter's room and discovered JonBenet was missing from her bedroom. Patsy Ramsey called 911 and reported the kidnapping to the Boulder, Colorado Police Department.

Officer Rick French arrived and conducted a preliminary examination of the Ramsey residence and was unable to locate JonBenet Ramsey in the home. Officer French requested assistance at the scene by way of his police radio.

Other Boulder Police Officers including Detective Linda Arndt responded to the scene. The scene was initially treated as a kidnapping. Telephone surveillance was initiated pending the anticipated telephone call from the kidnappers at 10:00 AM. The phone call was not received at the Ramsey home. At approximately 1:00 PM on the same date of 12-26-96, Detective Arndt asked John Ramsey and a friend of Mr. Ramsey, identified as Fleet White DOB/05-19-49 to search the home again.

John Ramsey and Fleet White entered the basement of the residence. John Ramsey found his daughter on the floor in a windowless storeroom. JonBenet Ramsey was partially covered with a blanket and had duct tape on her mouth. Ligatures were on her wrists and a garrote type device was around her throat. John Ramsey related that he removed the

duct tape from his daughter's mouth and one of the ligatures from her wrists and then picked her up and brought her upstairs. A red colored ink marking was noted on the palm of her left hand. Mr. Ramsey was instructed by Detective Arndt to lay his daughter on the floor of the hallway near the front door of the residence. A short time later JonBenet's body was moved from the hallway to the living room. JonBenet Ramsey was deceased and it appeared as though she had been murdered.

On 12-27-96 Dr. John Meyers, the coroner for the Boulder Coroner's Office, conducted an autopsy. The external examination of JonBenet Ramsey revealed she was attired in white colored sweatshirt or similar apparel and white colored sweat pants with an elastic waistband. Under the sweatpants, JonBenet wore white colored underwear bearing the lettering of "WEDNESDAY" on the elastic waistband. Suspected bloodstains were evident on the underwear. A bracelet was noted on JonBenet's right wrist. Inscribed on one side of the bracelet was the name "JonBenet" on the opposite side the date of "12-25-96" was inscribed. JonBenet's blonde hair was fixed in two (2) ponytails, affixed with either a cloth hair tie and/or blue elastic bands. Detectives with the Boulder Police Department, attending the autopsy, seized numerous items of evidence, including the aforementioned items of clothing, bracelet, rope ligatures and the garrote type device containing various knots. The handwritten ransom note was placed into evidence. These evidentiary items were later submitted to the Colorado Bureau of Investigation for analysis

The cause of death of JonBenet Ramsey as determined by Dr. Meyers was asphyxia by strangulation associated with craniocerebral injuries. Also there was evidence of trauma and bleeding to the vaginal area. The manner of death was Homicide.

On 12-30-96, the bloodstains obtained from the panties of JonBenet were submitted to the Colorado Bureau of Investigation for testing. The lab results indicated that the major component of blood was attributed to JonBenet Ramsey. A secondary minor component was also found.

A large number of witness were interviewed including all Ramsey family members, close friends of the Ramsey family, business associates of Mr. Ramsey coupled with a Neighborhood Investigation. Numerous items of evidence were collected and submitted to the Colorado Bureau of Investigation Crime Laboratory for forensic analysis. However, the case remained unsolved.

Criminalist Greg LaBerge of the Denver Police Laboratory conducted tests on the bloodstains found in the panties of JonBenet. The results indicated that the minor secondary source of DNA contained a male fraction.

On 01-07-04 the minor secondary source of DNA found in the bloodspots of the panties was submitted to the Combined DNA Index System (CODIS) Database to be compared with existing and future samples submitted.

On May 10, 2006, your affiant conducted an interview with Michael Tracey, DOB/08-07-48, a Journalism Professor with the University of Colorado. Mr. Tracey produced a documentary on the death of JonBenet Ramsey entitled, "JonBenet's America", which aired in Europe during July 1998. Mr. Tracey also produced another documentary entitled "Who Killed the Pageant Queen" that was aired December 2004 in the United States. Mr. Tracey advised your affiant, that on September 10, 2002, he received an E-mail from an individual identifying himself as "December 25 1996@Yahoo.com". I later determined the E-mail was received at 4:31 PM Mountain Standard Time (MST). The E-mail was entitled "Our Sweetest JonBenet". This marked the first of a series of E-mails Mr. Tracey received from "December 25 1996" during the next four years.

Mr. Tracey has provided your affiant with either printed copies of the E-mails he has received from the unidentified author or he has provided an electronic storage device containing the E-mails received

The writer used the name of "December 25 1996@Yahoo.com" initially with his correspondence with Michael Tracey.

Appearing for the first time, on an E-mail received by Mr. Tracey on November 23, 2002, received at 2:59 PM MST, titled, "An Important Message", is the name of December 1996 @ziplip.com.

Appearing for the first time on an E-mail received by Mr. Tracey on September 20, 2005, at 6:00 PM MST, titled, "Never a Response" is the name of "December 1996@Hushmail.com".

The individual identifying himself as "December 25 1996@Yahoo.com" advised Michael Tracey in his original E-mail sent on September 10, 2002 at 4:31 PM MST, titled, "Our Sweetest JonBenet", that he (December 25 1996@Yahoo.com) met an acquaintance of Mr. Tracey, while vacationing in Paris, France. The acquaintance of Mr. Tracey was later identified as: Michael D. Sandrock DOB/ 04-15-58.

Your Affiant conducted an interview with Michael Sandrock on May 12, 2006. Mr. Sandrock advised your affiant he recalled being in Paris, France approximately seven (7) years ago and met an individual at the "Shakespeare and Company" bookstore. Michael Sandrock advised the individual that he (Sandrock) was a reporter with the Boulder, Colorado Daily Camera Newspaper. The unidentified male immediately stated, "Boulder, that is where JonBenet Ramsey was killed."

The unknown male asked Mr. Sandrock if he was acquainted with Michael Tracey, a Journalism Professor with the University of Colorado. Sandrock stated he was familiar with Mr. Tracey and provided Michael Tracey's E-mail address to the unidentified male.

Mr. Sandrock described the unidentified male whom he conversed with at the Paris, France bookstore approximately seven (7) years ago as a Caucasian Male, mid 30's, medium height about height 5'08", slender athletic build, dark blonde collar length hair (full head of hair, no thinning) clean shaven, void of any visible scars, marks or tattoos. The male did not wear prescription lens glasses. He did not speak with an accent. The male did not exhibit a limp while walking. The male had a normal gait to his strides. According to Mr. Sandrock, the male was attired in a short sleeve shirt, possibly a polo style shirt. He wore slacks of an unknown color on one occasion and shorts of an unknown color on another occasion. Mr. Sandrock added, the male appeared "neat and clean" as opposed to many persons visiting the bookstore that were attired in hiking clothing and appeared to be "Backpacking through Europe. They can get a little grubby."

It should be noted, contained in an E-mail received by Michael Tracey from "December 1996" at an unspecified date and time and forwarded to former Inv. Lou Smit of the Boulder District Attorney's Office on May 4, 2006 at 10:54 AM MST, the male advised Mr. Tracey the aforementioned description as provided by Michael Sandrock was incorrect. 'December 1996" remarks, "I am not medium height. I am small. I do not have light hair. My hair is dark and my eyes are a piercing blue." Former Inv. Smit forwarded the aforementioned E-mail to your affiant on the same date of May 4, 2006.

Initially the E-mails received by Journalism Professor Michael Tracey, from "December 1996@Yahoo.com" contained voluminous amounts of verbiage indicating the writer's infatuation with young girls. Often writing about his love of young females and his continued love of JonBenet Ramsey.

Mr. Tracey has provided your affiant with either printed copies of the E-mails he has received from the unidentified author or he has provided an electronic storage device containing the E-mails received. Your affiant has reviewed the E-mail correspondence and determined the typical E-mail message provided to your affiant is a series of communications between Mr. Tracey and "December1996". Often Michael Tracey receives a message from the writer and the message is forwarded to your affiant's attention. This original message is followed by Mr. Tracey's reply to the writer. Contained within Mr. Tracey's reply are portions of the original text of the letter writer's response

A review of the supplied E-mail messages provided by Michael Tracey coupled with an interview your affiant conducted with Mr. Tracey on May 10, 2006 at 2:00 PM, the following information was gleaned.

Within an untitled E-Mail received by Mr. Tracey on December 31, 2002 at 5:24 PM Mountain Standard Time (MST) "December 1996@ziplip.com" writes "You are a special friend to me. You cannot know how important you are to me." The aforementioned verbiage is the first sentence in this E-mail that is five pages in length.

Michael Tracey received other E-mails from "December 1996@ziplip.com" detailing the writer's travels across Europe with "his girls" referring to the numerous young children in his company.

Contained within an E-mail received by Michael Tracey on January 3, 2003 at 6:04 PM MST, and titled, "My Daughter", "December1996@ziplip.com" the writer states, "I present to you a lovely child – a little girl who is so pretty and and (sic) with the power to captivate my heart and a thousand others like mine. I present to you: my daughter...." The writer adds, "I tend to think of Dodgson and his young Loves, much like my own, and his incredible way with them, most like my way with lovely little girls – the most incredible living beings on this earth..." The writer attaches a photograph of a young girl, attired in a large dark colored hat, light colored long sleeve blouse, dark overcoat and shoes. A bracelet is noted on her left wrist. She is lying on her stomach with her feet curled up near her back. Her Light colored hair is past her shoulders. She is holding the stem of a rose in her right hand with the rose near her mouth while her face is held in the palm of her left hand. She is smiling. The photo of the child is in black and white. The photograph is titled, "My Daughter."

In a January 12, 2003 E-mail received by Michael Tracey, at 6:40 AM MST, titled, "Important", "December 1996@ziplip.com" writes, "You have asked me who I am and so I will tell you. Yes, I am a psychic and yes I speak to the dead. But more than this, I am a kind, loving, affectionate person who cares for children. Just last night, I went to the bed of a lovely little girl and comforted her as she cried. She did not feel well, she said. I stroked her hair and face and said, "Sweetheart everything will be all right. I am here to help you and take care of you. I care for you so much." I am that man who watched this little girl smile with relief as she listened to those golden words flow so fluently from my mouth into her attentive, understanding ears. I kissed her softly good night and left her room not before I made sure the light flowed into her room to her liking. That, my friend, is who you are talking to. I am a man who cherishes little girls and protects them with all that is in him."

The E-mails from "December 1996@ziplip.com" continued through 2003. Typically lengthy messages were sent to Michael Tracey, often several pages in length, which Mr. Tracy responded to. On rare occasions, Michael Tracey did not respond immediately to the sender's E-mails, which prompted the sender to repeatedly remind Michael Tracey of his lack of response.

Mr. Tracey requested the sender of the E-mails, known only as December1996@ziplip.com to divulge his identity. Contained within an E-mail received by Mr. Tracey on August 26, 2003 at 2:49 AM MST, titled "An Appropriate Season", "December1996@ziplip.com writes, "After all the months we have talked and the guarding I have done, you would suggest I make an on camera appearance? And what do you expect me to say/ I am most surprised at you. I told you I would write under a pen name and collect proceeds through a European numbered account and you come back with this offer."

"December 1996@ziplip.com" continued to write to Mr. Tracey during 2003 detailing his love of JonBenet Ramsey. The writer mentions his visits to 755 15th Street in Boulder, Colorado, which is the residential address of the Ramsey family when the First Degree Murder of their daughter, JonBenet Ramsey occurred. The writer also mentions his visits to the grave of JonBenet Ramsey where he prayed for her. However, the writer provides no details of these visits. The writer only mentions the fact that he visited both the residence and the gravesite.

Mr. Tracey did not receive any E-mails from "December 1996@ziplip.com" during 2004.

Commencing September 20, 2005 at 6:00 PM MST, <u>December1996@hushmail.com</u> begins communicating again with Michael Tracey. The E-mail is titled, "Never a Response". The writer mentions within the September 20, 2005 E-mail, "Here is my final word to you and everyone involved in this case: You are chasing in the wrong direction (as always) and leaving the most important link to JonBenet behind. You chased me away."

The aforementioned E-mail was the first E-mail received by Michael Tracey with the sender's new address of "December1996@hushmail.com".

Within an E-mail dated October 7, 2005 bearing a time of 2:48 AM MST, titled, "JonBenet's Closet", Michael Tracey writes to "December 1996@hushmail.com", "The case is creeping away from everyone else and becoming a very chilly case. By the tenth anniversary it will be in deep freeze, unsolved and apparently unsolvable."

<u>December 1996@hushmail.com</u> answers, "It will continue to creep away until a new person rises up and speaks. I believe that person to be me though no one is listening publicly to me..."

Within the body of the same E-mail dated October 7, 2005,

December 1996@hushmail.com writes, "...I had spoken to the parents and the grandparents of JonBenet about this months or more prior to Lou Smit's revelation. Yes I have communicated with the Ramseys since her death. It was always to no avail. Recall the E-mail contact you granted. Nothing came of it and will not. I think it is too painful for them to communicate with me. I have always had such good rapport with parents."

The individual referred to as "Lou Smit" is former Investigator Lou Smit of the Boulder District Attorney's Office."

During the latter portion of 2005, <u>December1996@hushmail.com</u> continues to write of his fascination with and love for JonBenet Ramsey. The writer also mentions his love of little girls.

The communications between Michael Tracey and <u>December1996@hushmail.com</u> cease during January and February of 2006. Partly due to Mr. Tracey not responding to each and every E-mail that the sender had provided. Often, in past E-mail messages, <u>December1996@hushmail.com</u> instructed Mr. Tracey to answer specifically each question he had posed. If the answer was not provided, the writer would remind Mr. Tracey to provide the answer.

Commencing in March 2006, E-mail exchanges were initiated between Michael Tracey and December1996@hushmail.com. The following example received on March 11, 2006 at 4:47 AM, Mountain Standard Time (MST) titled, "My Last Two Letters", is illustrative of the E-mails the unknown writer has provided to Mr. Tracey. The text is copied verbatim from the E-mail received by Mr. Tracey and provided to your affiant by Mr. Tracey through an electronic storage device. The unidentified writer advises Mr. Tracey, a reply had not been received regarding E-mails he (December1996@hushmail.com) wrote to Mr. Tracey in January 2006. The text is provided unedited. Comments posted by Michael Tracey are indicated with punctuation marks of ">" or quotation marks which he himself wrote. The text is as follows:

A March 20, 2006 E-mail received by Michael Tracey at 11:57 AM MST titled, JonBenet Ramsey / My Response", "December 1996@hushmail.com" wrote the following, "I am attracted to little girls and not young girls. Though little girls are very young, young girls could be considered teens. There is a fine line that separates those who are attracted to little girls and those who are attracted to young girls. There is something psychological about everything; however I am in sharp disagreement that my attraction is to be labeled as a paraphillia in the respected Diagnostic and Statistical Manual of Mental Disorders where homosexuality once held a place in the paraphillia category until it became a political power."

A March 25, 2006 E-mail received by Michael Tracey at 6:08AM MST, titled, "Part I" "December 1996@hushmail.com" mentions, "My access to the internet is limited. I usually get an hour per day with no privacy which alters my writing to you. I think I will reply to this mail in parts." The writer adds within the text of the message, "The note was "written on paper found in the house......There was plenty of DNA". The writer also notes, "The killers were smart but the note was not so cleverly written."

Within the text of a March 26, 2006 Email received by Michael Tracey at 2:08 AM MST, titled, "Part 2 Plus", "<u>December1996@hushmail.com</u>" writes "I loved that time when I was still close enough to talk to the parents and grandparents of JonBenet. I think the Paughs dealt with the murder like the Ramseys should have dealt with the murder – a wreath placed on their front door with a card reading, "No Comment". The Ramseys have made so many mistakes exposing themselves to the press."

The name "Paughs" refers to the parents of Patsy Ramsey.

An E-mail received March 28, 2006 at 4:24 AM MST by Mr. Tracey and titled, "Kisses for JonBenet", "December 1996@hushmail.com" writes, "JonBenet was taken from her bed peacefully by a female. She was simply lifted into the girl's arms and carried quietly downstairs. The girl felt like her mother, smelled like her mother, was soft and sweet like her mother. JonBenet was a heavy sleeper. It was attributed to her bounding energy during her waking hours. She was quiet and reserved. She was playful and very alive.

When the time came for sleep, she slept hard. Nothing covered her mouth nor was she drugged or stunned or harmed in any way when she was removed from her bed. Genius, many times, overlooks simplicity."

The writer also mentions in the same E-mail received by Mr. Tracey on March 28, 2006, "I have had sex with teens and I have had sex with little girls. The experience is unreal and limited. That is what fuels the sexual frustration. The frustration is unreal. Most of my life has been celebate (sic) In every case where I had sexual or romantic relationship with a little girl, 10 or younger, I have gone straight to the mother and revealed my feelings and actions. Their reactions might surprise you."

Within an E-mail dated March 30, 2006 and received at 1:38 AM MST, titled, "My Kingdom for a Red Pen", <u>December1996@hushmail.com</u> begins to write of specific clothing items worn by JonBenet Ramsey on the night of her death. Specifically the writer mentions her underwear, which he describes as "knickers". He mentions the waistband of the victim's underwear contained the word "Wednesday" which in fact was printed on the underwear. The writer reiterates his love for JonBenet Ramsey and how her spirit was with him during a recent visit to Alps of Austria and Paris, France. Text preceded with a "<" punctuation mark, is authored by Michael Tracey. The following is a verbatim copy of the E-mail text exchanged between Michael Tracey and <u>December1996@hushmail.com</u>.

Within an E-mail dated March 31, 2006 bearing a time of 3:37 AM MST, titled, "Sentimental Objects", "December1996@hushmail.com" mentions in the body of the message, "...I have something on my mind that I must share. You refer to "souvenirs". It is not at all the correct term to be used. It must be referred to as a sentimental object removed" The writer adds, "I recall she was wearing a gold bracelet that night with the name JonBenet engraved on it. It was a Christmas gift. Do you know who gave it to her? The bracelet would have been priceless to anyone who would want to take something as a piece of sentiment. I recall her hair was held in place with hair ties or some sort. Those hair ties would have been something to take along with her hair. Her knickers were of great value to me. I cherish little girls' knickers of all kinds, especially of little girls 8 and younger and she was six.

Your affiant determined through an interview conducted with John Ramsey on May 16, 2006, the aforementioned bracelet bearing the name of JonBenet was a Christmas gift provided by John and Patsy Ramsey to their daughter. It should be noted, the autopsy report prepared by Dr. John Meyers, described the "ID" bracelet, including the name of "JonBenet" appearing on one side of an engraved plate and the date of "12-25-96" appearing on the opposite. Additionally the "hair ties" found in the hair of JonBenet, were also described in the autopsy report.

Mr. Tracey received an E-mail from December 1996@hushmail.com on April 2, 2006 at 5:09 AM MST, titled, "JonBenet/Wednesday, the writer responds to a statement previously posed by Mr. Tracey, in which Mr. Tracey mentions, "Your reference to the red pen intrigues me". Mr. Tracey is referring to the red colored ink mark on the palm of JonBenet Ramsey's left palm. The unidentified writer responds with, "Yes, it has all to do with the red heart drawn on JonBenet's left hand. I am not sure I am prepared to see photos of JonBenet-post mortem. I had quite a collection of photos of her alive when I was in the U.S. I also had a few of her funeral. In the raid on my house, law enforcement found all of them...."

The unknown writer also mentions in the April 2, 2006 message his desire to have physical relationships with young girls. The writer notes, "... The end of nine years old is usually the stopping point for me due to the physical height and development of the child. In some parts of the world, however, I have been highly attracted to girls who are 12 though they were the size of girls 8 in the US. I cannot say I was actually attracted to the 12 year olds but it was a little more tempting. I am attracted to dolls. When they get past the doll stage, I am no longer physically attracted..."

Contained in an E-mail received on April 4, 2006 at 5:00 AM, MST titled, "Contact is Imperative". <u>December 1996@hushmail.com</u> writes of his desire to contact the Ramsey family. He provides the last known address he had for John and Patsy Ramsey

The writer mentions he believes, "The killers need to have up to date contact information for the Ramseys. If in the unlikely event one of them might wish to make a confession. It would be made to Patsy Ramsey and not to you or to law enforcement."

The following is the entirety of the aforementioned E-mail authored by <u>December 1996@hushmail.com</u> dated April 4, 2006 at 5:01 AM, MST titled, "Contact is Imperative".

Often, throughout the four year exchange of E-mails "Decmeber1996@hushmail.com" will repeat information previously provided. Such was the case on April 4, 2006. The writer sent two (2) E-mails to Michael Tracey, each E-mail bore a date of April 4, 2006 and a time of 5:00:59 AM MST. Each E-mail was titled, "JonBenet / Contact is Imperative". The content of the second E-mail contains much of the same verbiage as was noted in the first E-mail dated April 4, 2006. However, within the second E-mail

dated April 4, 2006, the unidentified writer responds to a question posed by Michael Tracey that did not appear in the first E-mail dated April 4, 2006. Mr. Tracey had previously informed the unidentified writer that he (Tracey) was authoring his second book on the death of JonBenet Ramsey and mentioned the need of the writer to cooperate with him. Mr. Tracey asks, "What is it that you and only you can tell the reader about the crime that would astonish them and prove that you know things that others don't?"

"December 1996@hushmail.com replies in the second E-mail dated April 4, 2006, "I have no desire to astonish anyone. That would make me a sensationalist. I have some things to say but have no idea if it has been published or not. I do not read published information about the case. I cannot bear it. I never could."

Tracey inquires why the Federal Bureau of Investigation (FBI) focused on the writer in a prior homicide. "December 1996@hushmail.com" replies in the second April 4, 2006 E-mail, "It seems that I confided in a person about JonBenet and my love for little girls who turned out to be an informant. She recorded our phone conversations and met me with a wire on. It was pure deceit. I suspected it all along and even accused her of it several times. I had a weak moment and wanted to talk about JonBenet to someone. I chose the wrong person. It cost me everything. I hate myself for having met this person and further sharing things with her.

FURTHERMORE:

Her body (the 12 year old) was found within walking distance of my home in the state I resided in at the time. It was this unreal fact that lead law enforcement to really hone in on me. Her home was a city 20 miles or so away from my own city.

ADDITIONALLY;

I revealed information about JonBenet Ramsey that spurred an investigation. I am a teacher who has contact with thousands of little girls as well. It was not just JonBenet and the 12 year old. It was much more. There were other little girls involved and other charges."

Mr. Tracey received an E-mail on April 7, 2006 at 4:36 AM, MST, titled, "JonBenet/I Love Her", "December 1996@hushmail.com" writes, "Thanks for everything Michael. I have been thinking of the possibilities of writing with you. I think it is important that the world reads my words. You have the power to present my words to the world. I am prepared to seriously talk to you about the possibilities."

In an April 8, 2006 E-mail received by Mr. Tracey at 4:15 AM, MST, <u>December 1996@hushmail.com</u> writes in response to a question posed by Michael Tracey in which Mr. Tracey asks;

"THE OTHER THING I WAS WONDERING WAS WHETHER SHE WAS HOGTIED AS PART OF THE RITUAL.

The reply is:

I am not sure what that expression means. I will reveal one more fact to you that I do not believe you know. She was in the vertical position during the asphyxiation "ritual". Ritual is not really a proper term to use in the sense that you know as the definition of ritual. The asphyxiation was sexual and some sex acts are considered, ritual. The other fact is that she was not necessarily in the vertical position for the asphxiation "ritual" in the same area she was found in. I proposition you to revisit photos of that area and see if you can detect possible places she could have been placed in the vertical position OR the impossibilities of such. And one more revelation: the killers left at different times.

December 1996@hushmail.com writes in an E-mail received April 15, 2006 at 4:41 AM MST, titled, "JonBenet / Near Death", his understanding of the Modus Operandi utilized in the death of JonBenet Ramsey. The writer mentions "two distinct personalities, one was romantic and passionate. The other more pragmatic and violent which leads to the end result — one I do not like to think about." The writer also describes how JonBenet was placed in a vertical hanging position with her wrists tied together. Pressure was applied to her neck to deprive her of oxygen, causing "a dream like state." Sexual activity then was carried out, including the delivery of kisses then more asphyxia to heighten the sexual pleasure. Then pressure to her neck was released slowly. Following is the entire E-mail received on April 15, 2006. The "D" appearing at the end of the message refers to this initial which the writer often has ended his message with in the past. The writer later ended his e-mail messages with the name of DAXIS.

"FOR REASONS THAT I AM NOT CLEAR ABOUT THAT DIDN'T WORK OUT, SO THE SEX AND THE TORTURE HAD TO BE DONE THERE BECAUSE THERE WAS NO WAY THIS WASN'T GOING TO HAPPEN We must cure ourselves of this word torture. It was a sexual act. I could explain it to you. I shall explain a facet of it - the main core. She was aspyxiated, that you know. Do you know how? She was placed in a vertical hanging position, by the wrist in a more elaborate way than you might think. She would never be placed in a lying down position as this would cause blood to travel in more abundance to the head. Slow pressure was applied to her neck until average was argually deprived. Had it been quicker she would have oxygen was gradually deprived. Had it been quicker, she would have struggled. If done correctly, she would be in a dream state, much as one is during hyperventilation - which is exactly what it is. The pressure remains while sexual activity is being carried out on her - while the deliverer kisses her. In many, the asphyxia heightens sexual pleasure. The pressure is constant until the little girl passes out or comes near death. This takes two or three minutes. Then, the pressure is released slowly. This is the critical point. If the pressure is carried on for two or three minutes more, the little girl can die. The goal is to bring her near death - not to kill her. It takes consumate skill to know just when that time has elapsed. The deliverer is not using a stop watch. Two to three minutes depends on the age of the girl and the way the pressure is delivered. Five minutes can be deadly. The deliverer must know from signs in her face, for instance, when to stop delivering pressure. It is a difference of a mere two to three minutes from near death to certain death. That was a horror to write. I hope it means something to you. "THER NEED TO KISS HER KNECK, FEET AND TO HAVE ORAL SEX WITH HER OVERWHELMING. THE ULTIMATE FULFILLMENT OF THE FANTASY."

The ultimate fulfillment of the fantasy was the whole picture - the sexual asphyxia, the contact with her sex, the kissing of her neck and feet and other parts of her body. It was a symphony. "THEN SHE HAD TO BE KILLED BECAUSE SHE KNEW WHO HER KILLER WAS, DIDN'T SHE?"
That is not the reason for her death. Her death was not intended.

In an April 17, 2006 E-mail received by Mr. Tracey at 10:58 AM MST, titled "JonBenet's Mother", <u>December1996@hushmail</u> writes, "JonBenet's mother lives at 213 Elm Street, Charlevoix, Michigan 49720-1137. I believe I will be sitting in their living room before I get the phone number and E-Mail contacts I requested..." It should be noted the street address indicated by the writer i.e., 213 Elm Street, is a correct address of the Ramsey family, however this address is located in a different city than Charlevoix, Michigan.

An April 19, 2006 received by Michael Tracey at 4:52 AM MST, titled, "JonBenet/My Lover", <u>December1996@hushmail.com</u> writes, "There was a dance in the act performed with JonBenet but also a dance between two killers – one male and one female. The male is not necessarily the dominant one nor the violent one...." The writer also includes the following verbiage in the same E-mail, "...Yes, I am aware of the blunt trauma to her head. It was the worst of the end result. It went against all that I believed in because it tarnished my princess. Blood in small quantities is a different matter such as blood from her hot little cunt that I so wish I could drink at this very moment. But the trauma to her head haunts me – so horrible. An act committed to assure that she would not be alone, dying a slow death."

The writer again includes the aforementioned residential address of Patsy and John Ramsey, this being, 213 Elm Street, Charlevoix, Michigan.

Crime scene photographs taken of JonBenet Ramsey at the scene on December 26, 1996 in addition to autopsy photographs revealed no visible exterior trauma to the head. During the autopsy procedure performed by Dr. John E. Meyer M.D., an 8.5 inch fracture to the right side of the victim's skull was revealed.

I had these e-mail addresses and have asked you over and over about them and still no response from you. In one letter, I gave parts of the e-mail addresses without as much as a word from you. Again, they are N(a series of numbers)@aol.com and voyager@adelphia.net. The first I am certain belongs to John Ramsey. I don't know why I am bothering about this contact information. I feel it is useless.

Noted within an E-mail received on April 22, 2006 at 4:59 AM MST titled, "JonBenet's Mother With Me", "December 1996@hushmail.com" describes his method of kissing a "Living little girl". The writer notes his desire to communicate with Patsy Ramsey. The writer also describes his sexual encounter with an 8 year old girl. As is the case with the vast majority of the E-mails sent by this writer, the message is transmitted between approximately 3:30 AM, MST and 5:30 AM MST. The writer mentions, "My time has run out again." Referring to the fact his access to a computer is limited typically to an hour. The E-mail follows:

Noted within an E-mail bearing the date of April 22, 2006 and time of 4:05 AM MST titled, "JonBenet's Mother with Me", the unidentified writer stated, "In the case where I was investigated for the death of a twelve year old girl, there was a strange parallel. In close proximity, there was another twelve year old girl that I was terribly attracted to. She was abducted and murdered as well. The irony was that I was investigated for the death of the twelve year old girl who did not interest me at all."

The following is not easy to write. I will do my best. Please read

Dear Michael,

After all the frustration and upset I felt with you last week, your last mails are exactly how I wish you would respond to me always. First of all, don't write to me when you are drinking. I know all about drinking and how it changes you. I drink too. Just please promise me that you will always write as you have in these last three responses. I need you, Michael. If I cannot have you as a confident, I must find someone who can be a confident. I cannot bear keeping this inside any longer.

I am in the process of responding to two other mails. I wanted to respond to your idea of presentation of me to the Ramseys. I accept that your suggestions as you have written them are excellent

suggestions, if you talk to them directly. None of this relaying through friends of the Ramseys. Yes, I would like for you to tell them that a person you feel strongly to be JonBenet's killer (I hate that term) "WISHES TO SPEAK TO THEM, TO EXPLAIN WHAT HAPPENED THAT NIGHT AND TO EXPLAIN ALSO THAT THERE WAS NEVER ANY INTENTION TO KILL HER." Contained within an E-mail dated May 1, 2006 and received at 4:46 AM MST titled, "JonBenet's Parents", authored by <u>December1996@hushmail.com</u> the writer mentions he had blocked out thoughts for 10 years that are resurfacing. The writer adds, "I want to discuss the book and our collaboration. There must be some way we can manage it." Near the mid portion of the E-mail, the writer explains the duct tape covering the mouth of JonBenet, was "part of the kidnapping diversion that would coincide with the note." The writer also mentions, the duct tape was "placed on her mouth just prior to the fatal blow" to prevent blood from escaping from her mouth." The tape was not in place during the sexual encounter, according to the writer. The writer also notes, "JonBenet had a runny nose the night of her death. Did you read about that in the news?? Would you like to know more about that? Or have you "read about it" already?? Fucking Press. Fucking Law Enforcement."

Michael Tracey forwarded another E-mail he received on May 4, 2006 at 5:12 AM MST titled, "Collective Responses of Importance" from "December 1996@hushmail.com" to your affiant on the same date. Within the text of the E-mail, Michael Tracey poses a question regarding how little girls have seduced the writer. Mr. Tracey poses his question in all upper case lettering.

Tracey asks, "I ALWAYS HAVE THIS PERPLEXED FEELING ABOUT HOW LITTLE GIRLS HAVE SEDUCED YOU, INITIATED THE SEX. CAN YOU TELL ME MORE."

The unknown writer replies, "Ok Michael.... Try to put away your social programming and you might begin to understand. It is a long story that has spanned across years. I do not know where to begin. One little girl was with me on a bed once. She requested a massage. I obliged. She was

lying on her stomach. She kept telling me to go lower until I reached her bottom. I hesitated. She took my hand and placed it on her bottom. I massaged her there. She would leave momentarily to go to the bathroom. She would return with her tight jeans undone and pulled lower and lower, revealing her knickers and wanted more massage in that area. She would leave for the bathroom every 5 minutes. The massage turned into me passionately kissing her from her neck down her back and over her tight ass. This went on for awhile. This is what irritates me about this case and the media attention and even forensic and police work that supercedes all else. As for more misconceptions, I will reserve the ones about the female involvement in another mail to you. I just want to remove her from the equation. This is taking us two steps back... Mr. Tracey received another E-mail from December1996@hushmail.com on May 7, 2006 at 4:54 AM MST titled, "Last of the Series". The message is unusually lengthy. The writer states, "In conclusion, I wish to take full responsibility for all events that occurred that night..."

The writer mentions the potential success of the book Michael Tracey is writing on the death of JonBenet Ramsey including the information DAXIS is providing. The writer mentions his father was concerned over the numerous trips 'DAXIS' made to JonBenet Ramsey's gravesite.

The writer also states, "It was an intimate love affair for me. It was my secret and JonBenet's secret. They have no right to expose her and me. It hurts. There are so many lies. I don't want to share her with the media. I hate them and how they sell my darling little girl like a commodity."

The writer also mentions how he misses her grave and needed to be close to her body. "I should have taken her that night."

Within the text of the message, the writer identifying himself as DAXIS mentions John and Patsy Ramsey. He states he was with JonBenet Ramsey on the night of her death and attempted to revive her. DAXIS writes;

"Michael, I never said the Ramsey's would recognize my name. They will not recognize the name DAXIS. I was JonBenet's Closest, not theirs. I am very worried about JonBenet's mother. This is the best time to tell her about me. It has happened in the nick of time. I want to bring her peace. I will not do anything to harm her health. She will be cleansed. There is no need to protect her from me. I am here to help her. The question is, how can I gain John's trust. I promise not to go into any details at all about JonBenet's death. They need to know that she had a lover named DAXIS, that a dashing Prince was with her when she died; that she was not viciously murdered; that I cared for her and tried

to revive her when I thought she was dead. I loved her so much and I am so sorry that she died in my arms. But it is important that they know WHO she was with and how she died. For instance, she did not suffer. That would mean the world to a mommy to know that her little girl did not suffer, that she was not tortured. It appears that way. It appears brutal. It was not. Those parents see a horrified child awaiting a brutal end when in reality, she softly went to sleep and never awakened."

I used tight leather driving gloves while in the house prior to the Ramsey family's arrival that night and partially when I was with JohBenet. Within an untitled E-mail dated May 22, 2006, at 9:45 AM, DAXIS writes, "I'm sorry. What can I do about it now? The whole night, I was overcome with desire. Are you asking me why I killed JonBenet? I don't see it that way. I don't see myself as a killer. Her and I were engaging in a romantic and very sexual interaction. It went bad and it was my fault. I wish I had stopped at the first object. It would have been wonderful to have her live but that did not happen."

On May 24, 2006 at 9:50 a.m. Mountain Standard Time another e-mail was received by Michael Tracey from December 1996@hushmail.com. The untitled e-mail addressed the frustration of <u>December1996@hushmail.com</u> regarding a letter forwarded to John Ramsey. The author of the e-mail was also the author of the letter forwarded to Mr. Ramsey. The author of the e-mail (December 1996@hushmail.com) expressed his frustration at not being contacted or receiving any communication from Mr. Ramsey following the alleged receipt of the letter. Mr. Tracey advised December 1996@hushmail.com that in the future either John or Patsy Ramsey might forward a phone number for contacting them. Mr. Tracey encouraged the author of the email to speak with either John or Patsy Ramsey. Mr. Tracey added "I know you are worried about your safety but don't since law enforcement in Boulder is not looking for you." December 1996@hushmail.com replies "bullshit Michael. I am confessing to murder. How do I know that the Ramsey's who want so much to be exonerated are not plotting to snare me with law enforcement, tapping and tracing the phone conversations? I was not born yesterday and I was also the victim of this in the past. Please don't respond that I should not feel this way about the Ramsey's. You cannot judge what a parent might be capable of when it comes to the killer of their daughter."

Additional e-mails were exchanged between Michael Tracey and December1996@hushmail.com or DAXIS regarding frustration in not receiving a reply from John or Patsy Ramsey regarding the letter that was forwarded to them by DAXIS. Additionally DAXIS details his frustration with Michael Tracey in not answering each and every question posed in e-mails posed to Mr. Tracey.

Within an untitled e-mail dated May 28, 2006 at 2:10 p.m. Mountain Standard Time received by Michael Tracey from December1996@hushmail.com, the writer is informed by Mr. Tracey "Patsy read it" referring to the aforementioned letter that was forwarded to John and Patsy Ramsey previously. Within the aforementioned e-mail, DAXIS is informed that the cancer in which Patsy Ramsey has been suffering, has metastasized into her brain.

Within an e-mail entitled "a notes delivery" received by Michael Tracey on May 30, 2006 from December 1996@hushmail.com the writer identified himself as DAXIS

explains the location he placed the ransom note found in the Ramsey's residence by Patricia Ramsey on December 26, 1996. Within the body of this e-mail, DAXIS stated that he was carrying the handwritten note upstairs to lie on the pillow of JonBenet at which time he heard sounds within the residence. He believed the sound to be a voice. DAXIS indicates "I would never make to her bedroom to deliver the note. Instead I dropped it where I stood and quickly yet quietly made my escape. I made a mad dash for the basement. Halfway down into the basement, I realized I had no shoes on. I quickly yet quietly went back to the top of the stairs of the basement and retrieved my shoes. With not a moment to waste listening for yet more sounds. I made my way back down the stairs to my lover "JonBenet Ramsey" who awaited her funeral. I was terrified. For some reason I felt someone might have awakened in the middle of the night and might have by chance went in to check on JonBenet finding her gone. Though not likely, I feared they might have heard me and would have some way to know I was with her in the basement. One side of me discounted this is nonsense. The noise could have been in my own imagination. I had to escape quickly. There was no time for the funeral ritual I had in my mind for my little girl. I went to her once more. Unfortunately my ado would be bitterly cut short by any and urgency that I must escape quickly. My last moments with her were so short. I love you, sweetheart. Should I take you? But how? There is no time for that. It would be one of the biggest regrets I would have. I should have taken her body with me."

On several occasions Michael Tracey inquired from DAXIS how the circular markings appeared on the side of the face of JonBenet Ramsey at the time of her death. DAXIS or December1996@hushmail.com never admitted to the use of a stun gun. However within an untitled e-mail dated June 2, 2006 received by Michael Tracey from December1996@hushmail.com at 10:21 p.m. Mountain Standard Time, the author mentions that he used a "cross" composed of short arms that may have caused the marks on her face. The author wrote "the cross had short arms and could have terminated in small rectangular ends. The cross was of course close to the area of her face that has the marks. It would have been easy for me to have pressed the cross against her face. It might coincide with the reason one rectangular shape was larger than the other since the pressure against the skin from say the top end of the cross might have been greater than the tip end of the arms of the cross. The identical mark on her back might have occurred when I held the asphyxia object along with the cross in my hand as we kissed and as I caressed her just before I placed it on her neck and after I removed it from her neck."

Within an untitled e-mail dated June 5, 2006 received by Michael Tracey at 10:13 a.m. Mountain Standard Time, DAXIS reveals his excitement in realizing he may be speaking with either John or Patsy Ramsey within the next several hours. A time frame had been arranged by way of e-mails between Mr. Tracey and DAXIS for DAXIS to contact the Ramsey's. It should be noted that a specific telephone number had previously been assigned to the Ramsey residence while they were residing at 865 Brooksglenn Drive, Roswell, Georgia, 30075. The telephone line installed at the aforementioned residence is 770-641-1340. The phone number was installed by the Roswell Georgia Police Department. Within the body of the aforementioned June 5, 2006 e-mail authored by

DAXIS, he provided his phone number as "01160174182465." On the same date DAXIS placed a telephone call to the aforementioned-recorded telephone line at the Roswell Georgia address. He did not speak with either John or Patsy Ramsey however a telephone message was left by DAXIS on the telephone-recording device.

Following the aforementioned telephone call placed to the Ramsey residence in Roswell Georgia, DAXIS became upset that he did not receive a return telephone call. E-mails received by Michael Tracey authored by December1996@hushmail.com or DAXIS indicated DAXIS'S displeasure in not receiving a return telephone call from either John or Patsy Ramsey.

On June 11, 2006 at 1:47 p.m. Mountain Standard Time Michael Tracey received an e-mail from <u>December1996@hushmail.com</u> in which the author identified as DAXIS provides two new telephone numbers for Michael Tracey to contact him through. The first phone number is listed as "in England: 447787133033 outside England: 6679770681." The email is signed DAXIS.

Numerous additional e-mails are received by Michael Tracey from December1996@hushmail.com or DAXIS. The majority of these e-mails address the desire of DAXIS to have a manuscript he has been preparing, reviewed by Michael Tracey. DAXIS desires the manuscript to be published. DAXIS is hopeful that the manuscript will become a book. The manuscript details the life of DAXIS, his interaction with JonBenet Ramsey and a subsequent murder of this child.

Michael Tracey received portions of the manuscript during June and July of 2006. A review of the manuscript revealed that specific verbiage within the manuscript matched specific verbiage in many of the e-mails received by Michael Tracey that had been authored by DAXIS or December1996@hushmail.com. Additionally chapters of the manuscript coincided with titles appearing on the e-mails received by Mr. Tracey that had been authored by DAXIS or December1996@hushmail.com.

On June 29, 2006, Michael Tracey received from DAXIS also known as December1996@hushmail.com part one of the manuscript detailing the life of the author in addition to addressing the death of JonBenet Ramsey. During the month of July, Michael Tracey received part two of the manuscript. On August 10, 2006 Michael Tracey received part three of the manuscript authored by DAXIS or December1996@hushmail.com. The chapters of the manuscript are as follows.

Your Affiant determined through an Internet Search using the search engine of "Whois.com" that "Hushmail.com" is actually Hush Communications Anguilla, Inc, c/o Hush Communications Canada Inc. Suite 203, 455 Granville Street, Vancouver, British Columbia, Canada V6G1T1, Business Telephone: 604-685-6937, FAX: 604-685-6907.

On May 11, 2006 Inv. Andy Horita, a Commissioned Peace Officer with the Boulder District Attorney's Office conversed by way of telephone with representatives of Hush Communications Anguilla Inc, and determined "Hushmail.com" provides both non-fee and fee-based E-mail services and does not routinely forward the Internet Provider (IP) address of the E-mail sender, within the E-mail message forwarded by Hushmail.com. However, it is technically possible to capture the IP information from the company's server.

Inv. Horita was advised by representatives of Hush Communications Anguilla Inc in Vancouver, British Columbia, a request for the information should be placed through the Federal Bureau of Investigation and then submitted through the "Legal Attache" Format or LEGAT."

Therefore, on the same date of May 11, 2006, Inv. Horita spoke with Special Agent John Gedney of the Federal Bureau of Investigation, business address: 1050 Walnut Street, Suite 219, Boulder, Colorado 80302, Telephone: 303-443-4900. SA Gedney informed Inv. Horita that a request made through the aforementioned LEGAT process can be completed in a timely manner.

On May 11, 2006, following the conversation with SA Gedney of the FBI, Inv. Horita conversed with Royal Canadian Mounted Police constable Rod Giles (Telephone: 604-598-4083) Constable Giles stated he is the liaison of the RCMP with Hush Communications Anguilla Inc. Inv. Horita requested Constable Giles to contact Hush Communications Anguilla Inc and request the company take measures to capture the originating IP address and all E-mail messages sent from December1996@Hushmail.com. Also requested was a "Snapshot" be taken of the account information – including any fee based payment information and that the account holder not be notified of any actions taken. Also requested was any payment information if available be collected and forwarded to the Boulder District Attorney's Office. Constable Giles stated he would contact representatives of Hush Communications Anguilla Inc, in Vancouver British Columbia, Canada, and determine the correct process to acquire the requested information.

Inv. Horita was re-contacted by RCMP Constable Rod Giles on May 19, 2006 and advised the requested information would not be released through Hush Communications Anguilla Inc, without a Court Order.

On May 26, 2006 at approximately 3:10 PM, your affiant conversed with RCMP Constable Rod Giles and confirmed the aforementioned "Snapshot" had been captured on the "December1996@hushmail.com" account. However the account information and all other personal identifying information requested cannot be released to your affiant without a Court Order submitted through the Mutual Legal Assistance Treaty or MLAT the United States government has with Canadian authorities. The MLAT process routinely takes up to six (6) months for the process completion.

Your Affiant believes the individual identifying himself as "December1996@hushmail.com" and DAXIS has demonstrated through the aforementioned E-mails he has intimate personal knowledge of the events encompassing the death of JonBenet Ramsey. The person also has claimed responsibility for the First Degree Murder of JonBenet Ramsey as is outlined in his March 28, April 19, May 6, May 7, May 9, May 22, 2006 E-mails and insinuated within other E-mails. A review of the aforementioned E-mails follows:

March 28, 2006 E-mail:

The E-mail received by Mr. Tracey on March 28, 2006 at 4:24 AM MST and titled, "Kisses for JonBenet", "December 1996@hushmail.com" writes, "JonBenet was taken from her bed peacefully by a female. She was simply lifted into the girl's arms and carried quietly downstairs. The girl felt like her mother, smelled like her mother, was soft and sweet like her mother. JonBenet was a heavy sleeper. It was attributed to her bounding energy during her waking hours. She was quiet and reserved. She was playful and very alive. When the time came for sleep, she slept hard. Nothing covered her mouth nor was she drugged or stunned or harmed in any way when she was removed from her bed. Genius, many times, overlooks simplicity."

The writer also mentions "I have had sex with teens and I have had sex with little girls. The experience is unreal and limited. That is what fuels the sexual frustration. The frustration is unreal. Most of my life has been celebate (sic) In every case where I had sexual or romantic relationship with a little girl, 10 or younger, I have gone straight to the mother and revealed my feelings and actions. Their reactions might surprise you."

April 19, 2006 E-mail:

The April 19, 2006 E- mail received by Mr. Tracey at 4:52 AM, MST, titled, "JonBenet/My Lover", <u>December1996@hushmail.com</u> writes, "There was a dance in the act performed with JonBenet but also a dance between two killers – one male and one female. The male is not necessarily the dominant one nor the violent one...." The writer also includes the following verbiage in the same E-mail, "...Yes, I am aware of the blunt trauma to her head. It was the worst of the end result. It went against all that I believed in because it tarnished my princess. Blood in small quantities is a different matter such as blood from her hot little cunt that I so wish I could drink at this very moment. But the

trauma to her head haunts me – so horrible. An act committed to assure that she would not be alone, dying a slow death."

May 6, 2006 E-mail:

The May 6, 2006 E-mail Michael Tracey received at 7:43 AM MST, titled, "Intimate Moments" from "December 1996@hushmail.com". Mr. Tracey writes:

"...What becomes clear is that a kind of gentle touching, particularly with your tongue, is something that you find profoundly erotic."

<u>December1996@hushmail.com</u> responds, "That was not the important part. The fact that I drank her for the first time and it made me want her blood was the purely erotic and important theme."

May 7, 2006 E-mail:

The E-mail received by Mr. Tracey on May 7, 2006 at 4:54 AM MST titled, "Last of the Series" reads in part, "In conclusion, I wish to take full responsibility for all events that occurred that night..."

May 9, 2006 E-mail:

The E-mail received by Michael Tracey on May 9, 2006 at 5:18 AM MST, titled, "More of That Night" reads in part, "Michael, I never said the Ramsey's would recognize my name. They will not recognize the name DAXIS. I was JonBenet's Closest, not theirs. I am very worried about JonBenet's mother. This is the best time to tell her about me. It has happened in the nick of time. I want to bring her peace. I will not do anything to harm her health. She will be cleansed. There is no need to protect her from me. I am here to help her. The question is, how can I gain John's trust. I promise not to go into any details at all about JonBenet's death. They need to know that she had a lover named DAXIS, that a dashing Prince was with her when she died; that she was not viciously murdered; that I cared for her and tried to revive her when I thought she was dead. I loved her so much and I am so sorry that she died in my arms. But it is important that they know WHO she was with and how she died. For instance, she did not suffer. That would mean the world to a mommy to know that her little girl did not suffer, that she was not tortured. It appears that way. It appears brutal. It was not. Those parents see a horrified child awaiting a brutal end when in reality, she softly went to sleep and never awakened."

May 22, 2006 E-mail:

The untitled E-mail received by Michael Tracey on May 22, 2006 at 9:45 AM, DAXIS writes, "I'm sorry. What can I do about it now? The whole night, I was overcome with desire. Are you asking me why I killed JonBenet? I don't see it that way. I don't see myself as a killer. Her and I were engaging in a romantic and very sexual interaction. It

went bad and it was my fault. I wish I had stopped at the first object. It would have been wonderful to have her live but that did not happen."

The unidentified writer also describes his desire or describes actual physical acts of sexual intercourse with young girls as outlined in his E-mails dated March 28, April 19, May 6 and May 22, 2006. Of particular note is the fact the writer mentions in his April 19, 2006 E-mail, "Blood in small quantities is a different matter such as blood from her hot little cunt that I so wish I could drink at this very moment. But the trauma to her head haunts me – so horrible. An act committed to assure that she would not be alone, dying a slow death."

Your affiant conversed with Sgt. Cameron Rowe of the Roswell, Georgia Police Department on May 19, 2006 at approximately 9:00 AM Mountain Standard Time (MST). During this telephone conversation your affiant explained the need for an investigative tool, such as a land line (telephone line) installed at the Ramsey residence in Roswell, Georgia for the purpose of capturing the telephone conversation between December 1996@hushmail.com also known as DAXIS. Coupled with a trace of the incoming telephone call. Sgt. Rowe advised your affiant the Roswell Georgia Police Department could assist with the requested investigative tool.

On May 22, 2006 (Monday) at approximately 9:00 AM MST Sgt. Rowe advised your affiant the requested landline would be installed at the Ramsey residence in Roswell Georgia. A Consent Form would be presented to the Ramsey family for installation of the line. However, the Legal Department of Bell Telephone Company, which provides telephone service to the Ramsey residence, was requesting a Court Order for the installation of the telephone line.

Therefore, your affiant procured an Affidavit for Court Order, which will be forwarded to Sgt Cameron Rowe of the Roswell Georgia Police Department.

Purpose of the installation of the requested telephone line at the Ramsey residence would be of material aid in identifying information pertaining to the unknown caller, currently known only as December1996@hushmail.com. The installation of the requested telephone line would provide information pertaining to Subscriber information, Account Information, Credit Information, Billing Records, Call Origination / Termination Location and the Physical Address of the caller.

The installation of the requested telephone line with accompanying phone and telephone recording equipment was completed on June 2, 2006. The assigned number to the installed telephone was subsequently provided to the individual known as, "December 1996@hushmail.com. The same individual was also known as DAXIS as this was the name he was using to conclude E-mails messages he was routinely sending to Michael Tracey, who in turn, forwarded the messages to your affiant.

On June 4, 2006 at approximately 11:00 AM MST, a telephone call was received at the aforementioned installed telephone-recording device at the Ramsey residence in Roswell, Georgia. The caller identified himself as DAXIS. The call was approximately thirteen (13) seconds in duration. The caller mentioned he would like to speak with Patricia. The call ended with no further discussion.

On June 5, 2006 at approximately 10:13 hrs, MST an E-mail was received by Michael Tracey from "December 1996@hushmail.com. The writer requested Mr. Tracey contact him by phone and provided his telephone number of:

011-60-17-4182465.

The writer again ended his message with the name of DAXIS.

The first three numbers (011) are the International Access Code. The second series of numbers (60) is the "Country Code" assigned to the foreign country. The "Country Code" of 60 is assigned to Malaysia, according to the most recent published edition of the Qwest/Dex 2006 Metro Denver Telephone Directory. The time difference between Malaysia and the Mountain Standard Time Zone of the United States is "Plus 15 Hours", according to the aforementioned Qwest/Dex Telephone Directory.

On June 13, 2006 at approximately 12:44 PM, MST an E-mail was received by Michael Tracey from "December 1996@hushmail.com. The writer (DAXIS) stated:

"I am providing two phone numbers. The first is my number in England. The second is a number in another city outside of England. This second number outside of England will change every month for the duration that you have interest in talking to me. It is securely set up and will provide me the with greatest protection of Anonymity. For this reason, I ask that you use the number outside of England most often. The number in England is a personal number that could most likely be traced:

In England: +44 7787133033

Outside England: +66 79770681"

The writer again ended his message with the name of DAXIS.

On July 19, 2006 Michael Tracey received by way of e-mail from December1996@hushmail.com or DAXIS a message entitled "about". Within this e-mail DAXIS explains his initial meeting with He explains that while at school, he sat in the adult section of the cafeteria and no other adults were around. The female later identified as "was waving towards DAXIS and "acting silly". She eventually sat next to DAXIS. She identified herself a She stated she was five vears of age. Another female who identified herself as accompanied aid she was from South Africa. She mentioned that DAXIS was "a monster".

PAGE 58 replied "when I first DAXIS asked her why she would describe him as a monster. saw you I knew you were a monster. You look like a monster. I was scared of you. You "what did you think I would scared me." According to the e-mail, DAXIS asked then grabbed her side and said "I thought you do to you?" According to DAXIS, would grab me here and hurt me". DAXIS also mentioned in this e-mail that "then would pretend to take their eyes out and feed them to me along with yould then put little carrots on my plate other parts of their bodies. and and told her she was a princess. She loved and for me to eat. I then looked at asked later that I call her a princess again. I told I love those freckles on your replied would you like to eat them?" DAXIS replied "oh yes my love." hen pretended to feed her freckles to DAXIS and DAXIS "gobbled them up". bliged and laid her hand in his hand. DAXIS asked to see "your little hand" and DAXIS added "I thought of JonBenet and what it was like to hold her little hand." lovely little hand and traced along the inside of DAXIS also mentioned "I held her palm with my finger then up her wrist. I thought of JonBenet wrists and how I tied them up that night. I then just placed my other hand over her little hand and held her you're so precious my little darling". little tightly for a few seconds. And I said DAXIS then writes "I then saw her little bellybutton and said I would love to eat began pulling up her shirt and flashing her bellybutton. it". According to DAXIS, raised her shirt and flashed her bellybutton at DAXIS. DAXIS writes "I sat Then in a trance as I gazed at two five year olds flashing their hot little bellybuttons at me." DAXIS indicated "I then asked them if they would be students in the fall. They both said yes. I told them I would teaching second grade and it would be so wonderful to see them in the fall." DAXIS also indicated "I thought about JonBenet a lot while I was with

especially. No she did not look like JonBenet but she was five and little. She was so rull of life like JonBenet was. She was brave like JonBenet. She immediately bonded with me and quickly told me she liked me just like JonBenet. Her comments about me being a monster made me feel strange. Telling me she was scared of me was really bizarre. Of course she was acting silly the whole time she said it but there also seemed to be some kind of seriousness about it. It was as if she was saying she could detect something dark about me. She also ran her fingers across her neck and suggested that this is what I might do to her if I catch her. It was almost chilling as it reminded me of JonBenet. I have made my little friend

and ny friends. DAXIS explains that he was seated adjacent to and his hand dropped under the table. was tapping DAXIS with her little foot. DAXIS writes "I suddenly held onto her foot underneath the table. She was wearing sandals and I massaged her little foot with her sandal on it. She looked at me intently and with pleasure." DAXIS also indicates that he said "oh I love you. Your little foot is so precious". DAXIS writes "her naked little foot felt so sexy in my hand. It was almost like feeling her naked body sliding up next to me. Her little foot was divine. I looked down at it as I caressed it. Her little toenails were painted with glitter polish. Oh sweetheart I love this little foot." DAXIS concludes this e-mail by stating he regrets that he will not see her or be her teacher as she will be in first grade and he teaches second grade.

Ultimately a series of eleven (11) telephone calls have occurred between Michael Tracey and DAXIS. All calls were placed from the University of Colorado School of Journalism and Mass Communication, located in Boulder, Colorado, USA. Following is a list of the dates and time of the calls, all listed in Mountain Standard Time, which is two (2) hours earlier than Eastern Standard Time. Accompanying the dates and times are telephone numbers listing the number where the call was placed from and the telephone number where the call was received and the approximate length of time in minutes of the phone call. All calls were recorded by Digital Recording Device or Cassette Tape.

As previously documented, the first telephone call between Michael Tracey and DAXIS occurred on June 5, 2006 (Monday) at approximately 6:40 PM MST. Michael Tracey placed the call from telephone number 303-492-1357 at the University of Colorado School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at 60-174182465. The call was approximately 90 minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the call as DAXIS. During this telephone call DAXIS mentions his love of JonBenet Ramsey. DAXIS describes JonBenet as "an incredible little girl with maturity beyond her years. I would imagine that her maturity level was at least twelve or fifteen...it was past six." DAXIS said he engaged in autoerotic asphyxia with JonBenet Ramsey in the basement of her residence on the Christmas night of her death (December 25, 1996) by placing a

ligature around her throat and constricting the airway by tightening the ligature until JonBenet experienced a near state of unconsciousness. DAXIS then released the ligature, allowing JonBenet to regain consciousness. He repeated the procedure, however, on one of the procedures JonBenet did not regain consciousness and died in his presence. DAXIS said he was a "teacher" at the time he became acquainted with JonBenet Ramsey and was a teacher at the time of her murder. A Digital Recording Device recorded the telephone call.

The second telephone call placed by Michael Tracey to DAXIS occurred on June 24, 2006 (Saturday) at approximately 11:54 a.m. mountain standard time. Michael Tracey placed the call from telephone number 303-735-0021 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-79770681. The numerals "66" are the Country Code assigned to Thailand according to the most recent published addition of the Owest/Dex 2006 metro Denver telephone directory. The time difference between Thailand and the Mountain Standard Time zone of the United States of America is "plus fourteen hours" according to the aforementioned Owest/Dex telephone directory. The call was approximately ninety minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the phone as DAXIS. Michael Tracey informed DAXIS of the death of Patricia Ramsey. Patricia passed away at approximately 3:30 a.m. mountain standard time on June 24, 2006. Approximately five minutes into the call, DAXIS is heard crying. He states "I'll never hear her (Patricia) say I forgive you." "I'm never going to be able to say I'm sorry to her. I'd be in a five by nine cell now if I went to her. She meant so much to me." Approximately seven minutes into the call DAXIS stops crying. DAXIS mentions that due to the death of JonBenet Ramsey he "vanished off the face of the earth. I vanished from my family. I'll have no closure with JonBenet's mom. Her precious mom. I've been robbed." DAXIS then mentions a manuscript that he has been working on that he desires to provide to the world. DAXIS adds "for ten years I've been hiding. I blocked this out for ten years. I've blocked this out of my life for ten years." DAXIS also mentions "I stole John's daughter. I've stolen the daughter from parents before. Not killed them but stolen them. Ninety-nine percent of other dads despise me. Moms embrace me. Dads intimidate me." DAXIS also mentions "I don't want John catching me. I've been running for ten fucking years. If I ever got caught by law enforcement I'd kill myself. Patsy should have gone to Switzerland that's where I wanted to meet her. I had plans for her. My plans for her were huge. My book will be a huge success. I wanted to put Patricia Ramsey in a safe place in Switzerland. Now I've killed Patricia. I caused her stress. What happened to her little girl caused her stress." DAXIS added "I can't go into the United States. They have a warrant for me. If I step foot in that country they would arrest me." DAXIS also explains he was responsible for the death of a twelve year old female. DAXIS added that the murder of the twelve year old female was "a practice run for abducting a younger child" referring to the abduction and murder of JonBenet Ramsey. The telephone call was recorded by way of an audiocassette tape recording device.

The third phone call placed by Michael Tracey to DAXIS occurred on June 26, 2006 (Wednesday) at approximately 4:00 p.m. mountain standard time. Michael Tracey placed the call from telephone number 303-735-6235 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at the aforementioned phone number of 66-79770681. The call was approximately sixty minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the call as DAXIS. During this telephone call, DAXIS reiterated his love for JonBenet Ramsey. He again spoke of being with JonBenet Ramsey on the night of her death. DAXIS explained he was in the basement of the Ramsey residence on Christmas night when the death occurred. DAXIS explained that he used the aforementioned ligature or garrote that he had placed around the throat and neck area of JonBenet causing her to lapse into unconsciousness. DAXIS again mentioned his abduction of a twelve-year-old female and subsequent killing of the child. DAXIS said the child was found approximately "twenty miles from her home and walking distance from my home". He did not provide further details of the location of the crime. The telephone call was recorded by way of an audiocassette-recording device.

The fourth telephone call placed by Michael Tracey to DAXIS occurred on July 2, 2006 (Sunday) at approximately 11:00 a.m. mountain standard time. Michael Tracey placed the call from telephone number 303-735-0021 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-79770681. The call was approximately sixty minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the phone as DAXIS. During this telephone call DAXIS mentioned that he was "from Atlanta". Referring to Atlanta, Georgia, United States of America. DAXIS added that on the night of the death of JonBenet Ramsey he was in the basement area of the Ramsey residence. DAXIS added "I was in a room with no windows. I want to tell you Michael what happened. I want to tell you what JonBenet said on the night of the murder." DAXIS informed Michael Tracey that he had a strong desire to have a telephone conversation with John Ramsey. Furthermore DAXIS had a stronger desire to meet and speak with John Ramsey. During this conversation DAXIS continued to explain his continuing love for JonBenet Ramsey. The telephone call was approximately twenty minutes in duration. The telephone call was recorded by way of an audiocassetterecording device.

The fifth telephone call placed by Michael Tracey occurred on July 4, 2006 (Tuesday) at approximately 11:00 a.m. Mountain Standard Time. Michael Tracey placed the telephone call from telephone number 303-735-0021 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-79770681. The call was approximately 100 minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the phone as DAXIS. During this telephone call DAXIS explained his entry

into the Ramsey residence located in Boulder, Colorado, Unites States of America on Christmas night, December 25, 1996. DAXIS explained that he removed an exterior metal grate covering a lower level window well. Upon removal of the metal grate, DAXIS opened a basement level window and entered into the residence by way of the window. As he entered into the window DAXIS stated that he placed the metal grate back over the window well covering. DAXIS explained that he brought rope for the ligatures and garrote with him. He remained in the home for an unspecified amount of time prior to the arrival of the Ramsey family. DAXIS said he recalled hearing the garage door open and the Ramsey vehicle being driven into the garage area. He recalled hearing John Ramsey and Patricia Ramsey enter into the residence. He recalled hearing footsteps on an upper level stairwell leading to JonBenet's bedroom. DAXIS said he waited until he believed all occupants of the home were asleep then entered into JonBenet's bedroom obtained her from her bed as she was sleeping and carried the sleeping child down a stairwell into a basement level room. Within the room JonBenet was placed on his lap and he spoke with her and stroked her hair. DAXIS obtained rope he brought with him and formed ligatures, which he tied, around the wrist area of JonBenet. The same type of rope was placed around the ankles of JonBenet. He used the same type of rope to form a garrote, which he placed, around the throat area of JonBenet. DAXIS provided a detailed account of the manipulation of the garrote around the throat area of JonBenet. DAXIS explained how he tightened the garrote until JonBenet was nearly unconscious and then released pressure on the garrote allowing her to regain consciousness. He continued this procedure on more than one occasion however on the last such attempt, JonBenet did not regain consciousness. DAXIS said he was concerned that JonBenet may be suffering because of "twitching" that he observed therefore he struck her in the head with a flashlight. DAXIS said he removed the light colored pajamas that JonBenet was wearing and also removed underwear she was wearing. He described the underwear as "knickers". Repeatedly throughout this telephone conversation DAXIS referred to the underwear worn by JonBenet as "her knickers". DAXIS advised Michael Tracey that he removed the "knickers" from JonBenet and took the item with him after he left the Ramsey residence by way of the same point that he entered into the home. DAXIS added he placed underwear or "knickers" onto JonBenet that he brought with him. The underwear brought by DAXIS was several sizes too large for JonBenet. DAXIS mentioned that the oversized underwear also bore the day of "Wednesday". It should be noted that at the time of discovery JonBenet Ramsey at the lower level of her residence, she was in fact attired in light colored pajamas and oversized underwear designed for a twelve to fourteen year old female. The underwear bore the day name of "Wednesday". The telephone call between Michael Tracey and DAXIS was recorded by way of an audiocassette-recording device.

The sixth telephone call placed between Michael Tracey and received by DAXIS occurred on July 6, 2006 (Thursday) at approximately 11:30 a.m. mountain standard time. Michael Tracey placed the call from telephone number 303-735-6235 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-79770681. The call was approximately ninety minutes in duration. The voices on the

telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the telephone as DAXIS. During this telephone conversation DAXIS mentioned he had obtained a job as a teacher at an "International School". The school had been either remodeled or recently built. During prior e-mail messages between Michael Tracey and DAXIS it had been established that DAXIS was residing in the country of Thailand. It should also be noted that the aforementioned telephone number of 66-79770681 bears the Country Code of Thailand that being numeral "66". DAXIS added he had become infatuated with a young five-year-old '. DAXIS stated he was drawn extremely "blonde blue eyed little girl named close to the beauty of the child and desired to have a sexual relationship with off of my mind." However DAXIS explained he was having difficulty "getting during this same telephone call, DAXIS reiterated his continuing love for JonBenet Ramsey. He also spoke of his continuing work on the manuscript of his book, which he has entitled DAXIS detailing his love for JonBenet Ramsey and also detailing the death of this child. It should be noted DAXIS has forwarded by way of e-mail to Michael Tracey the first four chapters of the manuscript. Michael Tracey in turn has provided the four chapters of the manuscript to your affiant's attention. The first several chapters detail the early childhood of DAXIS being raised by an abusive mother who engaged in sexual relationships with DAXIS when he was between four and five years of age. The telephone call between Michael Tracey and DAXIS was recorded by way of an audiocassette recorder.

The seventh telephone call between Michael Tracey and DAXIS occurred on July 15, 2006 (Saturday) at approximately 11:30 a.m. mountain standard time. Michael Tracey placed the call from telephone number 303-735-0021 at the University of Colorado's School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-79770681. The call was approximately 100 minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the telephone as DAXIS. During this telephone call DAXIS provided additional details to the murder of JonBenet Ramsey. He describes the entry into the residence by way of removing a grate over the window well and entering through a basement level window. He describes ascending a stairwell leading to the bedroom of JonBenet Ramsey, carrying the child down to the basement. While in the basement area, light is provided by a flashlight he brought to the scene. DAXIS described removing the knickers (underwear) off of JonBenet. He kissed the child's body and massaged her feet. DAXIS performed oral sex on JonBenet Ramsey. DAXIS mentions he brought a "special box" to the scene that contained a "gothic cross". The box exhibited carving on the top portion or lid of the box. The cross, "Goes with a special necklace" according to DAXIS. The "necklace" as composed of rope with silk on each end according to DAXIS. The ends of the rope are tied to the cross. The rope was placed around the throat of JonBenet and tightened by use of the cross as JonBenet lapsed into unconsciousness. The tension was released and JonBenet regained consciousness. 'DAXIS" said he tied a piece of rope by a window in the basement, lifted up JonBenet, to allow her legs to encircle his abdomen and affixed the ends of the rope to JonBenet's

wrists. He then suspended the child near the window within the basement area. He did not explain how the child was suspended other than the fact she was suspended by her wrists. The clothing worn over the lower extremities of JonBenet was removed this included the bottom of the pajamas and her underwear. DAXIS said he fashioned a new "necklace" out of view of JonBenet Ramsey, and placed the "necklace" around the throat of the child. The new necklace was the garrote placed around the child's throat. Ultimately the aforementioned garrote composed of rope brought to the scene by DAXIS was tightened then loosened and subsequently tightened again at which time the child did not regain consciousness. DAXIS explained again that due to the twitching of JonBenet he was concerned she might be brain dead but her body could continue to survive. He did not want JonBenet to suffer, therefore he struck her in the head with a flashlight he brought with him. DAXIS added that the handle of the flashlight was wrapped in duct tape, which he had performed prior to the arrival at the Ramsey residence. DAXIS removed a section of duct tape from the handle of the flashlight and placed the piece of duct tape over the mouth of JonBenet to prevent her from bleeding on herself. DAXIS added he noticed JonBenet urinated, her underwear was soaked, he removed the underwear from JonBenet and took the item of clothing with him when he departed from the residence by way of the aforementioned basement window in which entry had originally been made. DAXIS added he placed the "knickers" of JonBenet into a small coffin like box that has "gothic writings on it". The small coffin like box was then placed in an area that DAXIS refused to identify. DAXIS said he performed oral sex on JonBenet Ramsey as she was suspended by her wrists, from the basement area window. He "pricked" the vagina of JonBenet with an item he did not describe. He "pricked" the vagina of JonBenet Ramsey three (3) times before a drop of blood appeared. DAXIS then placed his lips onto the vagina of JonBenet Ramsey, and licked the blood from her. DAXIS obtained a "stiletto" he brought to the scene and cut a lock of the child's hair. He used the same bladed instrument to cut the rope from the wrists of JonBenet. DAXIS, lowered JonBenet to the ground. He decided to place the ransom note he had prepared, on the bed of JonBenet and remove the child with him. DAXIS placed JonBenet in another room (the room she was subsequently located in). He ascended the stairwell leading to the child's bedroom, he heard a noise and descended. DAXIS placed the note on the stairwell. After retrieving his shoes, DAXIS departed through the same basement level window that he entered through.

During the aforementioned telephone call, specifically while DAXIS was explaining the sequence of events leading to the death of JonBenet Ramsey, DAXIS became emotionally upset. Audible sounds of crying were heard by Michael Tracey and captured on the recording device. DAXIS told Michael Tracey he was incapable of continuing the conversation. A period of approximately two (2) minutes elapsed with no verbiage being spoken by DAXIS. After the two minute elapsed time, DAXIS returned to the telephone and continued with the conversation with Mr. Tracey. During several other occasions within the same telephone call, DAXIS became emotionally upset, his voice pitch raised and sobbing is heard.

A review of the photographs taken during the autopsy of JonBenet Ramsey, revealed no markings on the wrists of JonBenet.

Your Affiant determined the phone call as recorded on July 15, 2006 is strikingly similar to "Part Two" of the manuscript authored by DAXIS

During the July 15, 2006 telephone call with Michael Tracey, DAXIS mentioned his fascination with he five-year-old blue-eyed blonde student in the class he was teaching. DAXIS added he was depressed due to the fact on July 14th the summer session of school he was teaching ended. DAXIS added he would not be able to see until school recommenced in August. He described the school as an international school that had recently been remodeled. He added new wooden floors had been installed. DAXIS said a "twenty five foot wall of solid glass" extended the full length of his classroom. He described "beautiful green plants" being directly outside of the glass. He added that the twenty-five foot wall of solid glass overlooked a row of large palm trees.

The telephone call between Michael Tracey and DAXIS was recorded by way of an audiocassette-recording device.

The eighth recorded telephone call placed between Michael Tracey and received by DAXIS occurred on July 22, 2006. However prior to the telephone call being placed, your affiant received a telephone call from Sgt. Cameron Rowe of the Roswell Police Department address 39 Hill Street, Roswell, Georgia, 30075, phone 770-640-4100. Sgt. Cameron Rowe had been assisting your affiant in the tracing of the aforementioned telephone calls placed by Michael Tracey and received by DAXIS. Special Agent Steve Paganucci of the Atlanta Field Office of the Federal Bureau of Investigations (FBI) in turn had assisted Sgt. Cameron Rowe in the tracing operation. Your affiant from the office phone of Michael Tracey dialed a series of telephone numbers that are being kept confidential for security purposes. The phone number dialed was that to a computer utilized for tracing of phone calls. The computer in turn read back a twenty digit numerical code, which was then relayed, back to Sgt. Cameron Rowe.

Therefore the eighth telephone call placed between Michael Tracey and received by DAXIS occurring on July 22, 2006 (Saturday) took place at approximately 10:36 hours Mountain Standard Time. Michael Tracey placed the call from telephone number 303-735-0021 at the University of Colorado School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at the telephone number previously mentioned of 66-79770681. However after several placements of the telephone call it was determined each call placed was reached by a busy signal. At 10:54 hours, your affiant requested Michael Tracey to send an e-mail to DAXIS at December1996@hushmail.com advising the aforementioned phone number provided was either busy or no longer in service.

At approximately 10:56 hours, your affiant requested Michael Tracey to call the telephone number of DAXIS one additional time. This call however did however ring

through to an operator speaking in Thai and English. The English message stated "unable to connect your call, call back later."

At 1100 hours your affiant requested Michael Tracey to send another e-mail to DAXIS advising calls cannot go through to his telephone number. Nearly immediately, Michael Tracey received an e-mail from December1996@hushmail.com advising that the sender believed "CU is blocking our call."

At 11:06 hours Michael Tracey receives another e-mail. DAXIS provides a new telephone number of "0116651086290".

At 11:08 hours the eighth telephone call placed between Michael Tracey and received by DAXIS commences. The telephone call is approximately thirty minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the phone answered the telephone as DAXIS. The majority of the telephone calls centered around DAXIS desiring John Ramsey to contact him in order for DAXIS to converse with Mr. Ramsey. DAXIS also spoke at length regarding the development of his manuscript.

The telephone call between Michael Tracey and DAXIS was recorded by way of an audiocassette-recording device which was retrieved by your affiant at the conclusion of the telephone call at 12:34 hours Mountain Standard Time.

The ninth telephone call placed between Michael Tracey and received by DAXIS occurred on July 29, 2006 (Saturday) at approximately 10:39 hours Mountain Standard Time. Michael Tracey placed the call from telephone number 303-735-6235 at the University of Colorado School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-51086290 the call was approximately eighty-four minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the telephone as DAXIS. The call was again traced through the assistance of Sgt. Cameron Rowe of the Roswell Police Department in Roswell Georgia and FBI Special Agent Steve Paganucci of the Atlanta Field Office of the Federal Bureau of Investigation. During the aforementioned telephone call, DAXIS spoke at length of his ability to impersonate individuals. He was especially proud of his ability to impersonate Kathryn Hepburn. DAXIS continued to speak of his fascination the aforementioned five-year-old student attending the school that DAXIS with " will be instructing at. DAXIS added "little girls can have sexuality that is not largely recognized". DAXIS claimed he had taught fifteen hundred young girls. He mentioned he is quite popular with young girls as a teacher. Twenty-nine minutes into the conversation, DAXIS mentioned that he told the mother of an eight year old he was having sex with her daughter. The mother said "she was flattered that DAXIS was having sex with her daughter." Forty-one minutes into the conversation, DAXIS stated "I do not like fathers period or fathers of little girls I loved." Forty-six minutes into the conversation. DAXIS begins to talk about financial rewards he is seeking through his

manuscript. He desires an "eighty twenty split" referring to eighty percent of the profits being received by DAXIS and twenty percent to Michael Tracey. DAXIS claims he desires to provide money to John Ramsey to assist Mr. Ramsey with his numerous financial obligations. Fifty-four minutes into the conversation DAXIS mentions he was sitting in his Jaguar in the driveway of the Ramsey residence. The Ramsey residence was located in "my neighborhood" referring to Paces Ferry area of Atlanta Georgia. During this conversation, DAXIS mentions that he also would like to have a movie made of his manuscript. He believes a billion dollars would be made. He desires the actor Johnny Depp to play the role of DAXIS. At fifty-nine minutes into the conversation the telephone connection was lost. At one hour and five minutes into the conversation the telephone was reconnected with DAXIS. Upon reconnection, your affiant departed the office area of Michael Tracey and informed by way of telephone Sgt. Cameron Rowe that the telephone call was reconnected. Your affiant then returned to the office of Mr. Tracey. The remainder of the conversation centered on the desire of DAXIS to provide additional information on the manuscript to Michael Tracey.

The aforementioned telephone call was recorded by way of an audiocassette-recording device.

On Sunday July 30, 2006, your affiant conversed with John Ramsey by way of telephone. "Arrangements were made for Mr. Ramsey to respond to the Boulder District Attorney's Office for Wednesday August 2nd for an interview at 2:30 p.m. Your affiant informed the elected District Attorney Mary Lacy, Assistant District Attorney Pete Maguire and the attorney of Mr. Ramsey, Bryan Morgan of the scheduled interview.

The aforementioned meeting with Mr. Ramsey took place on August 2, 2006 as scheduled at approximately 2:30 p.m. Location of the interview was the Boulder District Attorney's Office main conference room address 1776 Street, P.O. Box 471 Boulder, Colorado, 80306. In attendance were Mr. Ramsey, the elected District Attorney of Boulder County, Mary Lacy, Assistant District Attorney Pete Maguire, attorney Bryan Morgan who is the personal attorney of Mr. Ramsey, Inv. Mark Spray of the Boulder District Attorney's Office and your Affiant. Mr. Ramsey was advised of the progress of the on-going investigation into the death of his daughter. Mr. Ramsey was permitted to listen to the voice as recorded during the telephone calls between Michael Tracey and DAXIS. It should be noted that selected phrases were obtained through the telephone recordings capturing the voice of DAXIS. The phrases selected included verbiage uttered by DAXIS that were without emotion, verbiage that was uttered in an emotional manner or spoken quickly coupled with another portion of verbiage that was uttered by DAXIS in a slower manner. After listening to the recordings, Mr. Ramsey was unable to identify the voice.

On the same date of August 2, 2006, an interview was held with Michael Tracey at the Boulder District Attorney's Office. Your affiant had previously discussed with Michael Tracey the forwarding to DAXIS a photograph of JonBenet Ramsey and her mother. A specific photograph was identified as the "last known photograph" of the two individuals.

DAXIS had agreed during a prior e-mail to accept the item and provided a mailing address to Michael Tracey by way of e-mail. The mailing address was determined to be as follows:

The aforementioned address was received by Michael Tracey from December1996@hushmail.com through an e-mail dated August 3, 2006 at 9:35 a.m. Mountain Standard Time. DAXIS provided explicit instructions on how the item was to be shipped. He desired the photograph to be placed into a clear plastic sleeve, which would be surrounded by thick cardboard that would be secured with tape. The cardboard was to be then placed into a mailing envelope and shipped by way of UPS to the aforementioned address. During an interview with Michael Tracey on August 3, 2006, the aforementioned photograph was obtained. The photograph measures approximately eight inches in width by ten inches in height. It depicts JonBenet Ramsey adjacent to her mother Patricia Ramsey during a Christmas celebration of 1996. The photograph was subsequently shipped by UPS to DAXIS. Michael Tracey provided the UPS tracking number of 1ZE806076661000024 to DAXIS per his request by way of e-mail. The item was shipped on August 3, 2006 and was received in Bangkok at the aforementioned address on August 7, 2006 at 3:35 p.m. Thailand time which is 2:35 a.m. on August 7 Mountain Standard Time.

The tenth telephone call placed between Michael Tracey and received by DAXIS occurred on August 3, 2006 (Thursday) at approximately 8:14 p.m. Mountain Standard Time. Michael Tracey placed the call from telephone number 303-735-6235 at the University of Colorado School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-51086290. The call was approximately sixty-eight minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person receiving the call answered the telephone call as DAXIS. During the aforementioned telephone call DAXIS was provided the tracking information regarding the forwarding of the requested photograph to his attention. DAXIS stated that he was "depressed I had a few too many beers and some liquor." He stated he had been consuming wine in addition to the beer and liquor. DAXIS added that he had purchased a twenty one-speed mountain bicycle that he is riding to school. The majority of the remainder of the conversation addressed the desire of DAXIS to have his manuscript published and commence receiving proceeds from the publishing. The call concluded at 9:22 p.m. The telephone call was recorded by way of an audiocassette-recording device.

Information was provided to the Bangkok Police Department regarding the on-going investigation to the death of JonBenet Ramsey. Your affiant and Investigator Mark Spray of the Boulder District Attorney's Office worked jointly with the following individuals during the investigation.

As previously mentioned the package containing the photograph of JonBenet Ramsey arrived in Bangkok Thailand on August 7, 2006 at approximately 3:35 p.m. Bangkok time. Inv. Mark Spray responded to a UPS business and placed the eight-inch by teninch photograph into a mailing envelope measuring approximately twenty inches in length by thirteen to fourteen inches in width making it readily identifiable.

Your affiant and Investigator Mark Spray interacted with aforementioned law enforcement personnel in setting up a surveillance operation at the address in which the item was to be delivered. As previously mentioned the item was delivered on August 7, 2006 at Mail Boxes Etc. address 2929 Carrefour Rama 4, Ramafour Road, Klongtoey, Bangkok, Thailand. It should be noted that investigators with the Bangkok Police Department determined that Box 303 does not exist at Mail Boxes Etc. at the aforementioned 2929 Carrefour Rama 4 address. However Box 303 does in fact exist at another Mail Boxes Etc. located directly across the Rama 4 highway. A pedestrian bridge extends overhead interconnecting the two areas.

A surveillance operation was performed at the aforementioned Mail Boxes Etc. located at 2929 Carrefour Rama 4 in Bangkok Thailand. At approximately 4:00 p.m. on August 7, 2006 an individual riding a blue mountain bike arrived at the aforementioned business. The individual was described by Immigrations and Customs Enforcement Special Agent Gary Phillips, Assistant Attaché of the U.S. Embassy at Bangkok Thailand, as a Caucasian Male approximately forty years of age, 5'7" in height, 130 pounds in weight, with dark blonde or brown hair combed straight back. The hair was neatly trimmed around the ears and neck. The individual appeared to be "clean cut" according to Special Agent Phillips. He has a fair complexion and clean-shaven. The individual wore a short sleeve red shirt and blue jeans. The individual entered into Mail Boxes Etc. and obtained the package addressed to DAXIS. The individual tendered currency to a clerk. The individual proceeded to the exit door with the large twenty inch by fourteen-inch envelope however prior to exiting the business the individual stopped and turned facing the clerk. The individual was holding the manila envelope in his left hand. He extended his right hand towards the clerk made a fist then raised his thumb upward as in "thumbs up" gesture. The male paused for a second or two turned and then departed. The male was observed riding his bicycle from the area. The surveillance operation continued following the individual to an apartment complex located at: Blooms Residence 203-1 Soi #4, Soibumpen apartment 1927, Bangkok Thailand. Upon entry into the apartment complex, the surveillance team paused and did not follow the individual into the complex.

The surveillance team returned to the aforementioned Mail Boxes Etc. business and obtained video tape recordings of the transaction that have since been forwarded to your affiant.

On August 7, 2006, arrangements were made for Investigator Mark Spray of the Boulder District Attorney's Office, to obtain a flight and respond to Bangkok Thailand. Your affiant transported Investigator Spray to Denver International Airport. Investigator Spray departed from DIA at approximately 2:30 p.m. on Monday August 7, 2006 and arrived in Bangkok Thailand at approximately 1:40 a.m. on Wednesday August 9, 2006. Special Agent Gary Phillips of the Immigration and Customs Enforcement Division of Homeland Security responded to the Bangkok airport and met with Investigator Spray.

The surveillance team subsequently determined the individual obtaining aforementioned photograph from Mail Boxes Etc. resided in apartment 1927 of the aforementioned Blooms Residence located in Bangkok Thailand. Apartment 1927 is located on the ninth floor of this apartment complex.

Investigator Mark Spray contacted the office of the Blooms Residence and requested to rent a room preferably on the ninth floor. His request was approved. During the registration process, Investigator Spray was required to provide his passport for photocopying purposes. Upon inquiry, Investigator Spray determined all individuals renting a room at this apartment complex are required to provide their passport for photocopying purposes. Rooms could be rented hourly, daily, weekly or monthly.

The surveillance of the individual obtaining the aforementioned photograph from Mail Boxes Etc. in Bangkok Thailand, continued twenty four hours per day. Your affiant received updates throughout the day and evening from Investigator Mark Spray.

On August 11, 2006 (Friday) at approximately 4:25 a.m. your affiant received a telephone call from Investigator Spray. Your affiant was advised that the Thailand Royal Police had conducted a "spot check for passports" of foreign individuals, not from Thailand who were renting rooms at the Blooms Residence. As a result of the passport inspection, the individual residing within apartment number 1927 identified himself through his passport as John Mark Karr DOB 12/11/64. The individual identifying himself as John Mark Karr DOB 12/11/64 is in fact the same individual observed responding to Mail Boxes Etc. to obtain the photograph of JonBenet and her mother and returning to Blooms Residence on August 7, 2006.. The photo on the passport is an accurate representation of the physical description of John Mark Karr. Passport number assigned to Mr. Karr is _______. The most recently issued passport for Mr. Karr occurred during 2001 through San Francisco.

Your affiant determined through conversing with Michael Tracey that the individual known as DAXIS or <u>December1996@hushmail.com</u> sent an e-mail to Michael Tracey on Monday August 7, 2006 at 12:45 p.m. Mountain Standard Time (August 8, 2006 1:45 AM Thailand Time) indicating that he had obtained the package from Mail Boxes Etc.

The individual indicated "thanks to my contact, Akadaj in Thailand, I received a lovely photo of JonBenet and her mother. Michael, you gave my phone number to UPS. They called me today asking me questions, telling me I had to sign for the package and show I.D. I told them that would be tricky since I was not in the country. I assured them that my representative would sign on my behalf and send the package along to where I am now. It was strange. They called me twice. I traced the number back to UPS in Thailand. I know you gave my number for security of the arrival of the package."

As previously documented within this affidavit, the surveillance team members observed John Mark Karr DOB 12/11/64 respond to Mail Boxes Etc. obtain the package and respond to the Blooms Residence. No other individual was involved in the receipt of the package.

On August 11, 2006 at 8:48 AM MST, your affiant received by way of e-mail, six (6) photographs of DAXIS taken during the surveillance operations. Ann Hurst, Legal Attaché, Immigration and Customs Enforcement, U.S. Embassy Bangkok Thailand forwarded the photographs to your affiant. The photographs were received by your affiant on Friday August 11, 2006at 8:48 a.m. Mountain Standard Time.

Your affiant forwarded the photographs to John Ramsey by way of e-mail and Michael Tracey requesting they inform me if they recognize the individual. Mr. Ramsey subsequently informed your affiant that he did not recognize the individual depicted within the series of six photographs. Your affiant also provided the name of John Mark Karr to Mr. Ramsey. Mr. Ramsey advised your affiant he had never heard of the individual.

Your affiant provided the same series of six photographs by way of e-mail to Michael Tracey. Your affiant subsequently determined Mr. Tracey did not recognize the individual depicted therein. Your affiant did not divulge the name of Mr. Karr to Michael Tracey.

On August 11, 2006 (Friday) at approximately 6:00 p.m., your affiant contacted Michael Tracey by way of telephone and requested Mr. Tracey to place a telephone call to DAXIS at approximately 11:00 a.m. Mountain Standard Time on the following date of Saturday August 12, 2006. Your affiant provided a short script of topics to discuss that were mainly centered on proceeding forward with the manuscript. Mr. Tracey agreed to place the telephone call.

Your affiant conversed with Investigator Mark Spray who remains stationed in Bangkok Thailand. Investigator Spray was aware of the telephone call to be placed by Mr. Tracey to DAXIS at the specific time of 11:00 a.m. Mountain Standard Time which is midnight in Bangkok Thailand. Investigator Spray stated he would remain in the hallway and attempt to hear any verbiage being spoken by John Mark Karr during the telephone call.

The eleventh telephone call placed by Michael Tracey to DAXIS occurred on August 12, 2006 (Saturday) at approximately 11:12 a.m. Mountain Standard Time. Mr. Tracey placed the call from telephone number 303-735-6265 at the University of Colorado School of Journalism and Mass Communication located in Boulder, Colorado, United States of America. The call was received at telephone number 66-51086290. The call was approximately seventy-eight minutes in duration. The voices on the telephone were that of Michael Tracey and DAXIS. No other voices were heard. The person answered the phone stating "Michael?"

This marked the first time John Mark Karr had answered the phone in a name other than DAXIS. Michael Tracey asked DAXIS why he answered the phone in such a manner. DAXIS stated he believe he heard a pause on the telephone line and believed the call was being traced. Michael Tracey advised DAXIS that he was mistaken. DAXIS indicated he believed the call was being traced. Subsequently at 11:16 a.m. Mountain Standard Time the call was terminated by DAXIS by way of hanging up.

Your affiant who was present during the telephone call, requested Mr. Tracey to place another telephone call to the individual. Mr. Tracey desired to un-attach the telephone-recording device attached to his telephone. Your affiant instructed Mr. Tracey to leave the recording devices in place and re-contact the individual known as DAXIS. This was accomplished at 11:20 a.m. Mountain Standard Time.

During the telephone conversation, Michael asked DAXIS when he first met JonBenet Ramsey. DAXIS replied "I'm not going to tell you." DAXIS inquired why John Ramsey continues to refuse to talk to him. DAXIS added "he should know what happened. He should know what happened to his daughter. John doesn't know how she died. He knows physically how she died but not really how she died. I was there he wasn't there." DAXIS also stated "does John Ramsey have a warrant for his arrest? No he doesn't. I do. My life is shit."

DAXIS spoke of the five-year-old student whom he had affection for. DAXIS added "her first grade teacher I'm going to destroy him. I hate him. I hate fucking adults." DAXIS added "I work with a teacher who tried to get me fired but he got fired for indecent exposure."

DAXIS then spoke at length about the manuscript and his desire to receive compensation.

The telephone call was tape recorded by way of an audiocassette-recording device, which was tendered directly to your affiant by Michael Tracey at the conclusion of the telephone call.

During the telephone call, Investigator Mark Spray remained directly in the hallway adjacent to the entry door of apartment number 1927 of Blooms Residence, the aforementioned residence John Mark Karr DOB 12/11/64. Investigator Spray stated approximately nineteen minutes into the conversation he overheard John Mark Karr

speak of working with a teacher who attempted to get him (Karr) fired however the teacher was fired for indecent exposure.

Investigator Mark Spray stated he overheard numerous other statements uttered by Mr. Karr however they were somewhat unintelligible that is they were difficult to hear through the walls and door of Mr. Karr's apartment.

Investigator Spray advised your affiant that as he entered into the hallway and approached apartment number 1927, two individuals were standing directly adjacent to the door to the aforementioned apartment. One individual was to the right the other individual was to the left of the entry door. They stood with their arms folded and their feet slightly more than shoulder width apart. Their backs were towards the entry door therefore they were facing the hallway. Both individuals made eye contact with Investigator Mark Spray who was attired in casual clothing. Investigator Spray described the two individuals as resembling the majority of the citizens residing in Thailand. As Investigator Spray approached the area of the hallway adjacent to apartment number 1927, the shorter of the two males advised Investigator Spray "don't come down here". Investigator Spray smiled at both of the individuals stating "how ya'll doin'. I live on this floor". The shorter of the two individuals left his eyes focused on Investigator Spray and did not remove his stare from Investigator Spray. Therefore Investigator Spray departed the area. He returned approximately ten minutes later carrying a bottle of liquor in his right hand. He entered into the hallway and observed the two individuals turned and departed. Investigator Spray returned approximately one or two minutes thereafter and the individuals that had been standing adjacent to apartment number 1927 had departed. Investigator Spray disposed of the liquor bottle and began listening to the telephone conversation, shortly thereafter he overheard the comment regarding the teacher being terminated for indecent exposure.

Your affiant conducted a query through Colorado Department of Motor Vehicles and a national query of Colorado Department of Motor Vehicles which revealed John Mark Karr DOB 12/11/64 had been issued Alabama operator's license which revealed John Mark on 04/23/03. His social security number list as Mr. Karr is described as a male, height 5'6, weight 125 pounds with brown hair and blue eyes. Last known address in Alabama was 972 Sentry Road, Hamilton, AL, 35570.

Additionally your affiant determined John Mark Karr DOB 12/11/64 had been issued California operator's license D2411875 which expired on 12/11/03. At time of issuance of the aforementioned drivers license, Mr. Karr reported his residential address as 2120 Jennings Avenue, Apartment 606, Santa Rosa, California. He is described within his driver's license as a male, height 5'6", weight 140 pounds with brown hair and blue eyes.

A query through CCIC and NCIC revealed John Mark Karr, DOB 12/11/64, social security number 421-11-7566, has been issued California State Identification Number CA22088061 and FBI number 614817RB6. His birthplace is listed as Alabama. He is described as Caucasian male, height 5'6", weight 140 pounds with brown hair and blue

eyes. The aforementioned criminal history stems from a single arrest through the Sonoma County Sheriff's Office on 04/13/01 regarding possession of obscene material, (under age fourteen sex act). Currently a bench warrant has been issued for the arrest of this individual pursuant to California State Statute 311.11(A).

Your affiant has requested the assistance of additional Investigators with the Boulder District Attorney's Office including but not limited to Andy Horita and Legal Secretary Marci Lieberman to assist in collecting background information on John Mark Karr DOB 12/11/64.

On August 11, 2006 (Wednesday) your affiant received by way of e-mail from Michael Tracey, parts 1-3 of the manuscript prepared by DAXIS. The front page of the manuscript contains the word DAXIS in large print. At the bottom of the cover page appears the verbiage "Written by DAXIS / copyright 2006 / no part of this written work may be reproduced in any form without the consent of the author, DAXIS."

The manuscript contains one hundred and fifty three pages detailing the childhood life of DAXIS or John Mark Karr DOB 12/11/64. The manuscript also contains details of the murder of JonBenet Ramsey. The details appearing within this manuscript coincide with verbiage appearing in numerous e-mails received by Mr. Tracey. Additionally the verbiage in the manuscript also matches verbiage recorded on many of the aforementioned telephone calls received by DAXIS from Michael Tracey.

The aforementioned eleven telephone calls placed by Michael Tracey and received by DAXIS between June 5, 2006 through and including August 13, 2006, were either digitally recorded or recorded by way of an audio cassette recording device. Your affiant has listened to the audiocassette tape recordings and the digitally recorded telephone conversations. Your affiant has also conducted interviews with Michael Tracey regarding the content of the aforementioned telephone calls.

Your affiant continues to interact with Michael Tracey on a daily basis regarding e-mails received by Michael Tracey from December1996@hushmail.com also known as DAXIS and content of telephone calls placed by Michael Tracey to DAXIS.

On August 14, 2006, Boulder DA Inv. Andy Horita contacted the Colorado Department of Education's Educator Licensing Unit supervisor, Barbara Allen, located at 201 East Colfax Avenue, Room 105, Denver, CO 80203, Phone 303-866-6600; and learned that a file pertaining to John Mark Karr DOB/12-11-64, exists but is "confidential" pursuant to CRS 22-2-111(3). Allen advised Inv. Horita that the information contained in the file was forwarded to her department from the National Association of State Directors of Teacher Education and Certification's clearinghouse, but additional information could only be obtained through a court order. Subsequently, an Affidavit for Search Warrant and accompanying Search Warrant was obtained and forwarded to Colorado Department of Education's Educator Licensing Unit, on the same date of August 14, 2006. Requested were any and all documents, photographs, fingerprint cards, electronic files, applications,

or correspondence, contained in the Colorado Department of Education's Educator Licensing Unit's file for John Mark Karr DOB/12-11-64.

Your Affiant believes the individual identifying himself as "December1996@hushmail.com" and DAXIS has demonstrated through the aforementioned telephone calls he has intimate personal knowledge of the events encompassing the death of JonBenet Ramsey.

A review of the telephone calls placed by Michael Tracey and received by the person identifying himself as 'DAXIS" reveals:

DAXIS claims responsibility for the First Degree Murder of JonBenet Ramsey, causing her death on during the late evening hours of December 25, 1996(Christmas) or the early morning hours of December 26, 1996.

DAXIS provided details of the murder during a July 15, 2006 telephone call with Michael Tracey. DAXIS said he forcibly entered the Ramsey residence, removed JonBenet from her bedroom, carried her downstairs to the basement level, tied ligatures around her wrists, suspended her near a basement window, formed a garrote that he placed around the throat of JonBenet and tightened the device until JonBenet Ramsey lapsed onto unconsciousness. "DAXIS" claims responsibility of forcibly striking the head of JonBenet Ramsey with a flashlight that he wrapped with duct tape. DAXIS said he cut the vagina of JonBenet and drank her blood. DAXIS said he wrote a note that he left on a stairwell of the residence.

DAXIS claims he is currently teaching second grade at an International School in Thailand. The school was either recently built or remodeled.

DAXIS describes the classroom as having new wooden floors, a 25-foot long wall of solid glass extending the length of his classroom. Green plants and a row of palm trees are visible outside the glass wall.

DAXIS identified several of his students as, '

DAXIS provided details within an E-mail dated July 19, 2006 entitled "About DAXIS" and received by Michael Tracey of his encounter in a school lunchroom with 'a five (5) year old student. DAXIS provided details of the child exposing her navel (bellv button) to him, as did another student — DAXIS explained massaging foot under a table in the lunchroom. DAXIS detailed his desire to engage in a sexual relationship with

Detailed within prior E-mails received by Mr. Tracey, DAXIS described himself as a Caucasian Male, age 41, medium build, blondish/brown hair and "piercing blue eyes".

Your Affiant has informed Inv. Mark Spray, specific evidentiary items connected to this on-going investigation should be obtained through the assistance of the Royal Thailand Police from the residence of John Mark Karr DOB/12-11-64, AKA: DAXIS, located at:

AFFIDAVIT FOR ARREST WARRANT

Your, affiant, Thomas A. Bennett, a duly sworn commissioned investigator for the Boulder County District Attorney's Office, County of Boulder, State of Colorado, deposes and says:

Your affiant, Chief Investigator Thomas A. Bennett of the Boulder County District Attorney's has a total of 31 years of Law Enforcement experience.

Your affiant requests an Arrest Warrant be issued based on the following:

On 12/26/96, at 5:57 AM, a 911-telephone call was received at the Boulder Police Department, address 1805 33rd Street, Boulder, Boulder County, Colorado. The caller identified herself as Patricia Ann Ramsey, DOB/ 12-29-56. Patricia, or "Patsy" as she is known by her family and friends, reported her daughter –JonBenet Ramsey DOB/08-06-90 (age 6 at the time of the incident) had been kidnapped from the Ramsey residence located at 755 15th Street, City of Boulder, Boulder County, Colorado. Ms. Ramsey added a handwritten ransom note had been left in the house. The kidnappers demanded \$118,000.00. The kidnappers indicated in the note that they would call back at 10:00 AM with further instructions.

Boulder Police Department Crime Report P96-21871 addresses the investigation.

Boulder Police Officer Rick French was the first officer to arrive at the scene and made contact with the parents of the victim, identified as John Bennett Ramsey DOB/12-07-43 and his wife Patricia Ramsey. The parents related that the previous evening, this being Christmas day 12/25/96, they along with JonBenet Ramsey age 6 and JonBenet's brother identified as Burke Hamilton Ramsey DOB/01-27-87 (age 9) had attended a Christmas party at a friends house and had returned to the Ramsey home at approximately 10:00 PM. JonBenet was asleep in the family vehicle upon arrival at the Ramsey residence. John Ramsey carried JonBenet from the family vehicle to the second floor bedroom she occupied in the home. JonBenet was last seen in her bed asleep at approximately 10:00 PM on 12/25/96. John Ramsey, his wife Patsy Ramsey and their son Burke also retired at approximately 10:30 PM. John and Patsy Ramsey retired to their upper level master bedroom. Burke retired to his own bedroom.

The Ramsey family had previously prepared for a trip to Charlevoix, Michigan the next morning (December 26, 1996) using a small private airplane.

Patsy Ramsey stated she awoke shortly after 5:30 AM the morning of 12/26/96 and was going to prepare for the trip to Charlevoix, Michigan. Patsy Ramsey checked the bedroom of JonBenet and noticed her daughter was not in her bed. Patsy descended a spiral staircase leading from the second floor to the first floor and found a 3-page handwritten note on the stairs. Ms. Ramsey briefly reviewed the note and determined that it was a note demanding ransom for the return of their daughter, JonBenet. Patsy Ramsey told her husband John Ramsey of the discovery of the note. Patsy and John Ramsey checked their daughter's room and discovered JonBenet was missing from her bedroom. Patsy Ramsey called 911 and reported the kidnapping to the Boulder, Colorado Police Department.

Officer Rick French arrived and conducted a preliminary examination of the Ramsey residence and was unable to locate JonBenet Ramsey in the home. Officer French requested assistance at the scene by way of his police radio.

Other Boulder Police Officers including Detective Linda Arndt responded to the scene. The scene was initially treated as a kidnapping. Telephone surveillance was initiated pending the anticipated telephone call from the kidnappers at 10:00 AM. The phone call was not received at the Ramsey home. At approximately 1:00 PM on the same date of 12-26-96, Detective Arndt asked John Ramsey and a friend of Mr. Ramsey, identified as Fleet White DOB/05-19-49 to search the home again.

John Ramsey and Fleet White entered the basement of the residence. John Ramsey found his daughter on the floor in a windowless storeroom. JonBenet Ramsey was partially covered with a blanket and had duct tape on her mouth. Ligatures were on her wrists and a garrote type device encircled her throat. John Ramsey related that he removed the duct tape from his daughter's mouth and one of the ligatures from her wrists and then picked her up and brought her upstairs. A red colored ink marking was noted on the palm of her left hand. Mr. Ramsey was instructed by Detective Arndt to lay his daughter on the floor of the hallway near the front door of the residence. A short time later JonBenet's body was moved from the hallway to the living room. JonBenet Ramsey was deceased and it appeared as though she had been murdered.

On 12-27-96 Dr. John Meyers, the coroner for the Boulder Coroner's Office, conducted an autopsy on JonBenet Ramsey. The external examination of JonBenet Ramsey revealed she was attired in white colored sweatshirt or similar apparel and white colored sweat pants with an elastic waistband. Under the sweatpants, JonBenet wore oversized white colored underwear bearing the lettering of "WEDNESDAY" on the elastic waistband. Suspected bloodstains were evident on the underwear. A bracelet was noted on JonBenet's right wrist. Inscribed on one side of the bracelet was the name "JonBenet" on the opposite side the date of "12-25-96" was inscribed. JonBenet's blonde hair was fixed in two (2) ponytails, affixed with either a cloth hair tie and/or blue elastic bands. Detectives with the Boulder Police Department, attending the autopsy, seized numerous items of evidence, including the aforementioned items of clothing, bracelet, rope ligatures and the garrote type device containing various knots. The handwritten ransom note was

placed into evidence. These evidentiary items were later submitted to the Colorado Bureau of Investigation for analysis

The cause of death of JonBenet Ramsey as determined by Dr. Meyers was asphyxia by strangulation associated with craniocerebral injuries. Also there was evidence of trauma and bleeding to the vaginal area. The manner of death was Homicide.

On 12-30-96, the bloodstains obtained from the panties of JonBenet were submitted to the Colorado Bureau of Investigation for testing. The lab results indicated that the major component of blood was attributed to JonBenet Ramsey. A secondary minor component was also found.

A large number of witness were interviewed including all Ramsey family members, close friends of the Ramsey family, business associates of Mr. Ramsey coupled with a Neighborhood Investigation. Numerous items of evidence were collected and submitted to the Colorado Bureau of Investigation Crime Laboratory for forensic analysis. However, the case remained unsolved

Criminalist Greg LaBerge of the Denver Police Laboratory conducted tests on the bloodstains found in the panties of JonBenet. The results indicated that the minor secondary source of DNA contained a male fraction.

On 01-07-04 the minor secondary source of DNA found in the bloodspots of the panties was submitted to the Combined DNA Index System (CODIS) Database to be compared with existing and future samples submitted.

On May 10, 2006, your affiant conducted an interview with Michael Tracey, DOB/08-07-48, a Journalism Professor with the University of Colorado. Mr. Tracey produced a documentary on the death of JonBenet Ramsey entitled, "JonBenet's America", which aired in Europe during July 1998. Mr. Tracey also produced another documentary entitled "Who Killed the Pageant Queen" that was aired December 2004 in the United States. Mr. Tracey advised your affiant, that on September 10, 2002, he received an E-mail from an individual identifying himself as "December 25 1996@Yahoo.com". I later determined the E-mail was received at 4:31 PM Mountain Standard Time (MST). The E-mail was entitled "Our Sweetest JonBenet". This marked the first of a series of E-mails Mr. Tracey received from "December 25 1996" or "December 1996" during the next four years.

Mr. Tracey has provided your affiant with either printed copies of the E-mails he has received from the unidentified author or he has provided an electronic storage device containing the E-mails received. Your Affiant has personally review all of the E-mails

Michael Tracey received other E-mails from "December 1996@ziplip.com" detailing the writer's travels across Europe with "his girls" referring to the numerous young children in his company.

"December 1996@ziplip.com" continued to write to Mr. Tracey during 2003 detailing his love of JonBenet Ramsey. The writer mentions his visits to 755 15th Street in Boulder, Colorado, which is the residential address of the Ramsey family when the First Degree Murder of their daughter, JonBenet Ramsey occurred. The writer also mentions his visits to the grave of JonBenet Ramsey where he prayed for her. However, the writer provides no details of these visits. The writer only mentions the fact that he visited both the residence and the gravesite.

Mr. Tracey did not receive any E-mails from "December 1996@ziplip.com" during 2004. The writer changed his screen name to "December1996@hushmail.com" in September 2005.

December 1996@hushmail.com writes in an E-mail received April 15, 2006 at 4:41 AM MST, titled, "JonBenet / Near Death", his understanding of the Modus Operandi utilized in the death of JonBenet Ramsey. The writer mentions, "two distinct personalities, one was romantic and passionate. The other more pragmatic and violent which leads to the end result — one I do not like to think about." The writer also describes how JonBenet was placed in a vertical hanging position with her wrists tied together. Pressure was applied to her neck to deprive her of oxygen, causing "a dream like state." Sexual activity then was carried out; including the delivery of kisses then more asphyxia to heighten the sexual pleasure. Then pressure to her neck was released slowly. The writer ended the E-mail with the name of "DAXIS". This marked the first time in which the writer used the name of "DAXIS".

The writer now using the name as "DAXIS" continued to correspond with Michael Tracey via E-mail coupled with a series of eleven (11) telephone calls made between June 5, 2006 and August 12, 2006. All of the telephone calls were recorded and/or traced. Assisting with the trace were Special Agents of the Atlanta Office of the Federal Bureau of Investigation and Special Agents with the Immigration and Customs Enforcement located in Bangkok Thailand and the Thailand Royal Police. During a phone call of July 15, 2006, "DAXIS" provided a detailed accounting of the sequence he carried out on December 25 – 26, 1996 at the Ramsey Residence. "DAXIS" admitted to: 1. Forcibly entering the Ramsey home via of a basement window. 2. Entering JonBenet Ramsey's bedroom and carrying her to a basement level room. 3. Placing ligatures around her wrists and suspending her from an area by a basement window. 4. Placing a "necklace" he fashioned out of rope brought to the scene and tightening the garrote until JonBenet Ramey was unconscious.5. Placing duct tape on her mouth. 6. Striking her forcibly on her head with a flashlight he brought to the scene. 7. Cutting her vagina and drinking her blood. 8. Placing a handwritten note on the stairwell of the Ramsey Home. Then departing the residence. These admitted acts are consistent with the evidence observed at the autopsy of JonBenet Ramsey performed on 12-27-96 by Dr. John Meyer and with the evidence observed at the scene of the incident.

"DAXIS" forwarded to Michael Tracey via E-mail a 153-page manuscript detailing his involvement in the death of JonBenet Ramsey.

On August 3, 2006, "DAXIS" advised Michael Tracey he purchased a 21 speed Mountain Bike.

On the same date of August 3, 2006 (Thursday) a photograph of JonBenet Ramsey and her Mother Patricia (Patsy) Ramsey was packaged in an easily recognizable brown envelope measuring about 20 inches by 13 inches and forwarded through the United Parcel Service (UPS) to a location in Bangkok, that had been provided to Michael Tracey by "DAXIS" via E-mail. The address supplied by "DAXIS" was determined to be:

The business was later determined to be a "Mail Boxes Etc" during a surveillance operation conducted through the Immigration and Customs Enforcement (ICE) unit in Bangkok and with the assistance of the Thailand Royal Police, Department of Special Investigations (DSI). Special Agent Gary Phillips of ICE was assisted by other ICE Agents, Col Naras and Gen. Isaraphan of the Thailand Royal Police in addition to other investigators with the DSI.

The package arrived on August 7, 1006. An individual arrived at the business riding a mountain bike. The individual obtaining the package containing the photograph was observed by the surveillance team to personally obtain the package and pay for the item. The person obtaining the was described by SA Gary Phillips of ICE as a Caucasian Male, 5'07' in height, 140 pounds in weight, brown collar length hair combed straight back, clean shaven, not wearing any prescription lens glasses and attired in a red short sleeve shirt and blue jeans. The male was followed by the surveillance team to the "Blooms Residence, 203/1 Soi #4, Soibumpen, Apartment t 1927, Bangkok, Thailand.

"DAXIS" informed Michael Tracey via E-mail he had obtained the package and expressed elation of the beauty of the enclosed photograph. The E-mail is dated August 7, 2006.

A subsequent inspection of passports of individuals residing at the Blooms Apartment complex revealed the identity of the person residing at apartment 1927 was:

John Mark Karr DOB/12-11-64.

Physical Description: Caucasian Male, Height: 5'07", Weight: 140 pounds, brown collar length hair combed straight back, not wearing any prescription lens glasses.

The individual identified as John Mark Karr DOB/12-11-64 was the same person that obtained the package containing the photograph of JonBenet Ramsey and her mother, from the aforementioned Mail Box Etc store, according to SA Gary Phillips of ICE.

During an August 12, 2006 recorded telephone call between Michael Tracey and "DAXIS" or John Mark Karr DOB 12-11-64, Inv. Mark Spray of the Boulder District Attorney's Office, was on a surveillance operation directly outside the front door of Mr. Karr's apartment. Inv. Spray overheard verbiage uttered by the person inside apartment number 1927 of the Blooms Residence. The same verbiage heard by Inv. Spray was captured on the tape-recorded telephone conversation. The verbiage uttered addressed a teacher that "DAXIS" did not like who was subsequently terminated as a result of an Indecent Exposure incident.

Your Affiant has informed Inv. Mark Spray, specific evidentiary items connected to this on-going investigation should be obtained through the assistance of the Royal Thailand Police from the residence of John Mark Karr DOB/12-11-64, AKA: DAXIS, located at:






