

1946, January 6. Chicago, Illinois. Edwards kills 6 year old Suzanne Degnan. He lures Suzanne to let him into her house at night while her parents slept, just like he did to JonBenet in 1996. He dismembered Suzanne in a basement and placed her head in a public sewer the next day. Edwards taunted the parents with anonymous phone calls and left this ransom note on Suzanne's bed. This was Edwards' first JonBenet Ramsey 50 years before it happened.

April 28th 1955, Berkeley, California. Edwards Kidnaps and kills 14 year old Stephanie Bryan. He sends a ransom note that will be similar in syntax as the JonBenet Ransom Note that he will write 40 years later in 1996. (Reproduced)

"Bryan:
Don't be Idiotic. This is not a
hoax. Don't contact any law enforces
if you expect to see your ~~daughter~~
in the near future. ^{girl}

Your instructions are on Tuesday,
May 3 have 8000 to 10,000 no
less than 10000 in 5-10-
20. Wrap it in a small box then
wrap the box in brown paper.
9:30 p.m. GO to the T and D
Theatre be in the last Row of
the television lounge at 9.

There you will be contacted. Give
the box to your contact. He will
give you instruction. Follow them
and you will reach your child.

Don't contact anyone it will
take the package a while to
reach me but your child will
be okay if you follow Instruction.
If the man that contact you in the
theatre is followed the instructions
won't do you any good. Wear
Brown HAT. PUT Pipe in mouth
don't drive your car. I have my reasons
for waiting before contacting you. Things
HAVE BEEN CAREFULLY Planned. So Don't be Foolish"

1996, December 25th. Boulder Colorado. Edwards kills JonBenet Ramsey while her parents slept and places her in the basement like he did to Suzanne Degnan in 1946. He leaves a ransom note that has the same syntax as Suzannes, Stephanies and the Robert Wiles Ransom Note he will leave in 2008

Mr. Ramsey,
Listen carefully! We are a group of individuals that represent a small foreign faction. We ~~don't~~ respect your business but not the country that it serves. At this time we have your daughter in our possession. She is safe and unharmed and if you want her to see 1997, you must follow our instructions to the letter.
You will withdraw \$118,000.00 from your account; \$100,000 will be in \$100 bills and the remaining \$18,000 in \$20 bills. Make sure that you bring an adequate size attache to the bank. When you get home you will put the money in a brown paper bag. I will call you between 8 and 10 am tomorrow to instruct you on delivery. The delivery will be exhausting so I advise you to be rested. If we monitor you getting the money early, we might call you early to arrange an earlier delivery of the

money and hence a earlier ~~delivery~~ pick-up of your daughter. Any deviation of my instructions will result in the immediate execution of your daughter. You will also be denied her remains for proper burial. The two gentlemen watching over your daughter do ^{not} particularly like you so I advise you not to provoke them. Speaking to anyone about your situation, such as Police, F.B.I., etc., will result in your daughter being beheaded. If we catch you talking to a stray dog, she dies. If you alert bank authorities, she dies. If the money is in any way marked or tampered with, she dies. You will be scanned for electronic devices and if any are found, she dies. You can try to deceive us but be warned that we are familiar with Law enforcement countermeasures and tactics. You stand a 99% chance of killing your daughter if you try to outsmart us. Follow our instructions

and you stand a 100% chance of getting her back. You and your family are under constant scrutiny as well as the authorities. Don't try to grow a brain John. You are not the only fat cat around so don't think that killing will be difficult. Don't underestimate us John. Use that good southern common sense of yours. It is up to you now John!

2008, April 1st. Lakeland, Florida. Edwards kidnaps Robert A Wiles on April Fool's Day, 2008. This was also Edwards' mother's birthday. (Cecelia Myers, April 1, 1911)

We have Robert. If you hope to see him alive again you must follow our instructions without deviation!

1. Do not speak about this to anyone including family tell everyone Robert is ill
2. Do not contact ANY authorities or private parties
3. Obtain an item of luggage of the appropriate size and place in it \$750,000 in small unmarked untraceable bills.
4. Place the luggage containing the money in a plain cardboard box and ship it to your lakeland facility with detailed instruction that it is highly confidential materials for a special project that your son is working on. You should instruct someone you trust to place the box unopened in your son's office.
5. This must be completed by the evening of the 8th. NO EXCUSES! NO EXCEPTIONS!

Remember we are watching everything and if you think you can out smart us it will cost your son his life.
